The Registration of Marriages (Amendment) Regulations 2011

Made--26th April 2011Coming into force in accordance with regulation 1(2)

The Registrar General(1), in exercise of the powers conferred by sections 27(1), 74(1)(b) and 78(1) of the Marriage Act 1949(2) as extended by section 26(3) of the Welsh Language Act 1993(3), with the approval of the Secretary of State(4) makes the following Regulations:

# Citation and commencement

**1.**—(1) These Regulations may be cited as the Registration of Marriages (Amendment) Regulations 2011.

(2) These Regulations shall come into force on the day on which the Asylum and Immigration (Treatment of Claimants, etc.) Act 2004 (Remedial) Order 2011(5) comes into force.

2.—(1) The Registration of Marriages Regulations 1986(6) are amended as follows.

# **EXPLANATORY NOTE**

(This note is not part of the Regulations)

These Regulations amend the Registration of Marriages Regulations 1986 and the Registration of Marriages (Welsh Language) Regulations 1999 to reflect the amendments made to the Asylum and Immigration (Treatment of Claimants, etc.) Act 2004 by the Remedial Order under section 10(2) of the Human Rights Act 1998 following judgement in the case of "Baiai and others v Secretary of State for the Home Department [2006] EWHC 823 QB". The amendments in these Regulations remove the declaration on the forms for giving notice of marriage which require a person subject to immigration control to provide evidence of eligibility.
