The Welfare Reform Act 2012 (Commencement No. 19, 22, 23 and 24 and Transitional and Transitory Provisions (Modification)) Order 2016

Made - - - 29th September 2016

The Secretary of State for Work and Pensions makes the following Order in exercise of the powers conferred by section 150(3) and (4)(a), (b)(i) and (c) of the Welfare Reform Act 2012(1):

Citation

1. This Order may be cited as the Welfare Reform Act 2012 (Commencement No. 19, 22, 23 and 24 and Transitional and Transitory Provisions (Modification)) Order 2016.

Interpretation

2.—(1) In this Order—

"the Act" means the Welfare Reform Act 2012;

"claimant"—

- (a) in relation to an employment and support allowance, has the same meaning as in Part 1 of the Welfare Reform Act 2007(2);
- (b) in relation to a jobseeker's allowance, has the same meaning as in the Jobseekers Act 1995(3) (as it applies apart from the amendments made by Part 1 of Schedule 14 to the Act that remove references to an income-based jobseeker's allowance);
- (c) in relation to universal credit, has the same meaning as in Part 1 of the Act(4);
- "the Claims and Payments Regulations 1987" means the Social Security (Claims and Payments) Regulations 1987(5);

"employment and support allowance" means an employment and support allowance under Part 1 of the Welfare Reform Act 2007;

- "jobseeker's allowance" means a jobseeker's allowance under the Jobseekers Act 1995;
- "the No. 9 Order" means the Welfare Reform Act 2012 (Commencement No. 9 and Transitional and Transitory Provisions and Commencement No. 8 and Savings and Transitional Provisions (Amendment)) Order 2013(6);
- "the No. 19 Order" means the Welfare Reform Act 2012 (Commencement No. 19 and Transitional and Transitiony Provisions and Commencement No. 9 and Transitional and Transitory Provisions (Amendment)) Order 2014(7);
- "the No. 22 Order" means the Welfare Reform Act 2012 (Commencement No. 22 and Transitional and Transitory Provisions) Order 2015(8);

- (3) For the purposes of this Order, the Universal Credit, Personal Independence Payment, Jobseeker's Allowance and Employment and Support Allowance (Claims and Payments) Regulations 2013(11) apply for the purpose of deciding—
 - (a) whether a claim for universal credit is made; and
 - (b) the date on which the claim is made.
- (4) For the purposes of this Order, the Claims and Payments Regulations 1987 apply, subject to paragraphs (5) and (6), for the purposes of deciding—
 - (a) whether a claim for an employment and support allowance or a jobseeker's allowance is made; and
 - (b) the date on which the claim is made or treated as made.
 - (5) Subject to paragraph (6), for the purposes of this Order—
 - (a) a person makes a claim for an employment and support allowance or a jobseeker's allowance if he or she takes any action which results in a decision on a claim being required under the Claims and Payments Regulations 1987; and
 - (b) it is irrelevant that the effect of any provision of those Regulations is that, for the purposes of those Regulations, the claim is made or treated as made at a date that is earlier than the date on which that action is taken.
 - (6) Where, by virtue of—
 - (a) regulation 6(1F)(b) or (c) of the Claims and Payments Regulations 1987(12), in the case of a claim for an employment and support allowance; or
 - (b) regulation 6(4ZA) to (4ZD) and (4A)(a)(i) and (b) of those Regulations(13), in the case of a claim for a jobseeker's allowance,

a claim for an employment and support allowance or a jobseeker's allowance is treated as made at a date that is earlier than the date on which the action referred to in paragraph (5)(a) is taken, the claim is treated as made on that earlier date.

 - (ii) in the case of joint claimants, either or both of the joint claimants gives or give incorrect information regarding his or her (or their) residing in such a

district and one or both of them does not or do not reside in such a district on the date on which the claim is made,

and after a decision is made that the single claimant is, or the joint claimants are, entitled to universal credit and one or more payments have been made in respect of the single claimant or the joint claimants, the Secretary of State discovers that incorrect information has been given regarding residence.";

 - "(7) Paragraphs (1A) and (1B) of article 5 of the No. 9 Order apply for the purposes of the sub-paragraphs referred to in sub-paragraph (rr) as they apply for the purposes of article 4(2)(a) of the No. 9 Order (but as if the references in paragraph (1A) to Schedule 5 to the No. 9 Order were omitted)."

- (b) article 2(3) (amendments to the gateway conditions) were omitted;

 - "(dd) a claim for universal credit that is made on or after the date referred to in the relevant preceding sub-paragraph, in respect of a period that begins on or after that date where—

and after a decision is made that the single claimant is, or the joint claimants are, entitled to universal credit and one or more payments have been made in respect of the single claimant or the joint claimants, the Secretary of State discovers that incorrect information has been given regarding residence.";

- (d) for article 3(5) (article 3A of the No. 9 Order and incorrect information) there were substituted—
 - "(5) Article 3A of the No. 9 Order applies in connection with a claim for universal credit where a single claimant, or, as the case may be, either or both of joint claimants, gives or give incorrect information regarding his or her (or their) residing in a numbered relevant district referred to in paragraph (2), as it applies in connection with the giving of incorrect information regarding a claimant residing in one of the relevant districts (as defined in the No. 9 Order).";

- (e) for article 4(2)(ggg) (abolition of income-related employment and support allowance and income-based jobseeker's allowance and incorrect information) there were substituted—
 - "(ggg) a claim for universal credit that is made on or after the date referred to in the relevant preceding sub-paragraph, in respect of a period that begins on or after that date where—
 - (i) in the case of a single claimant, the claimant gives incorrect information regarding the claimant residing in a district as referred to in the sub-paragraph in question and the claimant does not reside in such a district on the date on which the claim is made;

 - (d) a reference to paragraph (1) and sub-paragraphs (a), (b), (e) and (h) of paragraph (2) of article 3 of the No. 22 Order, in respect of claims in relation to which those sub-paragraphs are modified respectively by articles 4(2)(a), 9(2)(a), 10(2)(a), 11(2)(a) and 12(2)(a), articles 7(2)(b), 8(2)(b), 10(2)(b) and 11(2)(b), articles 10(2)(c) and 12(2)(b) and articles 4(2)(b), 6(2)(a) and 12(2)(c) of this Order;
 - (e) a reference to paragraph (1) and sub-paragraphs (a), (c), (e), (k), (m) and (s) of paragraph (2) of article 3 of the No. 24 Order, in respect of claims in relation to which those sub-paragraphs are modified respectively by articles 11(2)(c), 11(2)(d), 6(2)(b), 4(2) (f), 7(2)(d) and 8(2)(e) of this Order; and

(f) a reference to paragraph (1) and sub-paragraphs (d), (h), (j), (p) and (r) of paragraph (2) of article 3 of the No. 24 Order, in respect of claims in relation to which those sub-paragraphs are modified respectively by articles 9(2)(c), 11(2)(e) and 12(2)(f), articles 4(2)(d), 6(2)(c) and 11(2)(f), articles 4(2)(e) and 7(2)(c), articles 10(2)(d) and 12(2)(g) and articles 3(2) (b), 4(2)(g), 5(2), 8(2)(d), and 11(2)(g) of this Order.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order modifies a series of prior Orders (the "prior commencement Orders", defined below) bringing into force provisions of the Welfare Reform Act 2012 (c. 5) ("the Act") relating to universal credit ("UC") and the abolition of income-related employment and support allowance and income-based jobseeker's allowance. Those prior commencement Orders are:

(a) the Welfare Reform Act 2012 (Commencement No. 19 and Transitional and Transitory Provisions and Commencement No. 9 and Transitional and Transitory Provisions (Amendment)) Order 2014 (S.I. 2014/2321 (C. 99));

- (b) the Welfare Reform Act 2012 (Commencement No. 22 and Transitional and Transitory Provisions) Order 2015 (S.I. 2015/101 (C. 6) ("the No. 22 Order")); and
- (c) the Welfare Reform Act 2012 (Commencement No. 24 and Transitional and Transitory Provisions and Commencement No. 9 and Transitional and Transitory Provisions (Amendment)) Order 2015 (S.I. 2015/1537 (C. 87) ("the No. 24 Order")).

Articles 3 and 4 of each of the prior commencement Orders brought into force respectively provisions relating to UC in Part 1 of the Act ("the UC provisions"), as set out in Schedule 2 to the Welfare Reform Act 2012 (Commencement No. 9 and Transitional and Transitory Provisions and Commencement No. 8 and Savings and Transitional Provisions (Amendment)) Order 2013 (S.I. 2013/983 (C. 41) ("the No. 9 Order")), and provisions of the Act relating to the abolition of incomerelated employment and support allowance and income-based jobseeker's allowance ("the amending provisions").

The modifications to the provisions of articles 3(2) and 4(2) of the prior commencement Orders by paragraph (2) of articles 3 to 12 of this Order remove the restrictions on claiming UC applied in the prior commencement Orders ("the gateway conditions", set out in Schedule 5 to the No. 9 Order) so that they do not apply to the specified provisions of articles 3(2) and 4(2) of the prior commencement Orders for the coming into force of the UC provisions and the amending provisions in the postcode districts and part-districts specified.

Articles 3 to 12 of this Order apply where claims are made (as the case may be) for universal credit, an employment and support allowance or a jobseeker's allowance on or after: 5th, 12th, 19th and 26th October 2016; 2nd, 9th, 23rd and 30th November 2016; 7th and 14th December 2016, respectively; and by reference to residence in one of the designated postcodes in the corresponding Part of the Schedule to this Order. *See* article 2(2) for the definition of these postcodes.

Articles 13 to 15 of this Order make consequential modifications to a number of similar provisions in each of the prior commencement Orders to remove references to meeting the gateway conditions. By virtue of the gateway conditions no longer applying, claims by couples will become possible for the first time in certain of the designated postcodes, those for which UC was commenced under the No. 22 Order and the No. 24 Order for single UC claimants only. The consequential modifications by articles 14 and 15 to those Orders also allow for claims by couples.

Article 16 modifies article 7 of the Welfare Reform Act 2012 (Commencement No. 23 and Transitional and Transitory Provisions) Order 2015 (S.I. 2015/634 (C. 32)) such that, save in specified cases, a person may not make a claim for housing benefit, income support or a tax credit on any date where, if that person made a claim for UC on that date, the UC provisions would come into force by virtue of any of the sub-paragraphs of article 3(2) of the prior commencement Orders modified by paragraph (2) of articles 3 to 12 of this Order.

Article 17 makes a technical amendment to article 9(2)(e) of the Welfare Reform Act 2012 (Commencement No. 13, 14, 16, 19, 22, 23 and 24 and Transitional and Transitory Provisions (Modification)) Order 2016 (S.I. 2016/596 (C. 41)). This applies the consequential modification made by that article for the purposes of the amending provisions modified by article 5(2)(b) and (c) of that Order.
