The Secretary of State, in exercise of the powers conferred by sections 26A(1), 26B(1) and 53 of the Firearms Act 1968(1), makes the following Rules.

#### Citation and commencement

**1.** These Rules may be cited as the Firearms (Amendment) Rules 2017 and come into force on 31st December 2017.

#### **Amendments to the Firearms Rules 1998**

2. The Firearms Rules 1998(2) are amended as follows.

#### Amendments to rule 3 of the Firearms Rules 1998

- 3. In rule 3 (firearm certificates)—
  - (a) in paragraph (3)(b), for "four photographs" substitute "a photograph";
  - (b) after paragraph (7), insert—

"(8) The requirements in paragraphs (1) and (7) above are satisfied if the information required by the relevant form is transmitted electronically to the chief officer of police for the area in which the applicant resides.

(9) An application transmitted electronically in accordance with paragraph (8) above must be in accordance with the process for the electronic submission of applications approved by the chief officer of police for that area.

(10) A chief officer of police may only approve a process for the electronic transmission of applications that has been approved by the Secretary of State.".

#### Amendment to rule 4 of the Firearms Rules 1998

**4.** In rule 4(3) (referees: firearm certificates), after the words "police employee" insert ", a police and crime commissioner or a member of their staff, a member of the Scottish Police Authority or a member of staff of the Scottish Police Authority,".

#### Amendments to rule 5 of the Firearms Rules 1998

- 5. In rule 5 (shot gun certificates)—
  - (a) in paragraph (1), for the words "Schedule 2" substitute "Schedule 1";
  - (b) after paragraph (1) insert—

"(1A) The requirement in paragraph (1) above is satisfied if the information required by the relevant form is transmitted electronically to the chief officer of police for the area in which the applicant resides.

(1B) An application transmitted electronically in accordance with paragraph (1A) above must be in accordance with the process for the electronic submission of applications approved by the chief officer of police for that area.

(1C) A chief officer of police may only approve a process for the electronic transmission of applications that has been approved by the Secretary of State.";

(c) in paragraph (3)(b), for the words "four photographs" substitute "a photograph".

#### Amendment to rule 6 of the Firearms Rules 1998

**6.** In rule 6(2) (referee: shotgun certificate), after the word "family," insert "a serving police officer or police employee or a registered firearms dealer, a police and crime commissioner or a member of their staff, a member of the Scottish Police Authority or a member of staff of the Scottish Police Authority,".

#### Amendment to rule 7 of the Firearms Rules 1998

7. For rule 7 (photographs to accompany application) substitute—

#### "7 Photograph to accompany application

(1) The photograph referred to in rules 3(3)(b) and 5(3)(b) above must show the current true likeness of the applicant and either:

- (a) measure 45mm by 35mm, or
- (b) be transmitted by electronic means in the form approved by the chief officer of police for the area in which the applicant resides.

(2) Where an applicant applies for a firearm certificate and a shotgun certificate simultaneously, the applicant need only submit one photograph.".

#### Amendments to Schedule 1 to the Firearms Rules 1998

8. In Schedule 1 (form of application for firearm and shotgun certificates, and firearm certificate)

(a) for the form in Part 1 (application for the grant or renewal of a firearm or shotgun certificate), substitute the form in Schedule 1 to these Rules (application for the grant or renewal of a firearm or shotgun certificate);

(b) for the form in Part 4 (application to vary a firearm certificate), substitute the form in Schedule 2 to these Rules (application to vary a firearm certificate).

#### **Transitional arrangements**

**9.**—(1) An application for a firearm certificate or a shotgun certificate may continue to be made using an application form which is replaced by virtue of rule 8(a) if it is received by the chief officer of police for the area in which the applicant resides on or before 28th February 2018.

(2) An application to vary a firearm certificate may continue to be made using an application form which is replaced by virtue of rule 8(b) if it is received by the chief officer of police for the area in which the applicant resides on or before 28th February 2018.

(3) The changes made by rules 4 and 6 of these Rules have no effect in relation to an application for a firearm certificate or a shotgun certificate that is received by a chief officer of police on or before 31st December 2017.

# NOTES Please read these <u>BEFORE</u> completing the form

You must complete all parts of the form for the type of certificate for which you are applying. For electronic applications, each data field must be completed.

FIREARM: Section 1 of the Firearms Act 1968 (as amended) applies to all firearms except:

- a shotgun;
- an air weapon (unless declared 'specially dangerous');
- prohibited weapons such as centre fire selfloading rifles, handguns, machine guns etc (unless specifically authorised).

<u>SHOTGUN:</u> Section 1(3)a of the Firearms Act 1968 (as amended) defines a shotgun as:

- a smooth bore gun (not being an air weapon);
- having a barrel not less than 24" (60.96cm) in length and a bore not exceeding 2" (5.08cm) in diameter;
- iii. either having no magazine, or a nondetachable magazine incapable of holding more than two cartridges;
- iv. not a revolver gun.

#### Referees

- When applying for a firearm certificate, you should have gained the permission of <u>two people</u> who have agreed to act as referees for you. You must complete Parts F and G with their details. When applying for a shotgun certificate you should have gained the permission of <u>one person</u> to act as a referee for you. You must complete part F with their details.
- 2. The referee(s) who have agreed to act for you must have known you personally for at least two years and must be resident in Great Britain. A referee must not be a member of your immediate family, a registered firearms dealer, a serving police officer, a police employee, a Police and Crime Commissioner or a member of their staff, or a member of, or a member of staff of, the Scottish Police Authority. Referees must be of good character and any references they agree to provide must be given freely and not on payment.

#### Coterminous applications

3. To apply for both a firearm certificate and a shotgun certificate and to have them expire at the same time (coterminous certificates) you should complete the sections for firearm and shotgun certificates. The fee payable for such certificates may be less than the normal fee for the grant or renewal of a shotgun certificate if both of your applications are dealt with at the same time.

#### Medical information

4. You must disclose any relevant physical or mental health conditions that you have been diagnosed with or treated for in the past as this may affect your ability to safely possess and use a firearm or shotgun. Relevant medical conditions which must be disclosed are listed in note 5. Sections 27 and 28 of the Firearms Act 1968 (as amended) specify that in order to issue a firearm or shotgun certificate the chief officer of police must be satisfied that an applicant can be permitted to possess a gun 'without danger to the public safety or the peace'. Medical fitness is one of the factors police must consider when assessing a person's suitability.

- Relevant medical conditions which must be disclosed are:
  - Acute Stress Reaction or an acute reaction to the stress caused by a trauma
  - Suicidal thoughts or self harm
  - Depression or anxiety
  - Dementia

5.

- Mania, bipolar disorder or a psychotic illness
- A personality disorder
- A neurological condition: for example, Multiple Sclerosis, Parkinson's or Huntington's diseases, or epilepsy
- Alcohol or drug abuse
- Any other mental or physical condition which might affect your safe possession of a firearm or shotgun

If in doubt, consult your GP or contact the police firearms licensing department.

- 6. If you have disclosed a relevant medical condition the police may ask you to obtain a medical report from your GP/specialist. You are expected to meet the cost if a fee is charged for this. If further information is required the police may request and pay for a further report.
- 7. Where no relevant medical conditions are disclosed the police will contact your GP asking if they are aware of any relevant medical conditions or have any concerns about the grant of the firearm or shotgun certificate. Depending on the reply, the police may ask you to obtain a medical report from your GP/specialist. You are expected to meet the cost if a fee is charged for this. If further information is required the police may request and pay for a further report.
- 8. The police will ask your GP to place an encoded reminder on your patient record to indicate that you have been issued with a firearm or shotgun certificate. The GP is asked to notify the police if, following issue of the certificate, you are diagnosed with or treated for a relevant medical condition (listed in note 5), or if the GP has other concerns about your possession of a certificate that might affect your safe possession of firearms. Following contact from your GP there may be a need for a medical report to be obtained to assist with assessment of your continued suitability to possess a firearm or shotgun certificate. The police will pay if a medical report is required.
- 9. Following the issue of a firearm or shotgun certificate please note that the declaration you have signed consenting to information sharing between your GP and police applies during the application process <u>and</u> during the validity of any firearm or shotgun certificate, which may be up to five years.
- You are expected to inform the police if, following issue of the certificate, you are diagnosed with or treated for a relevant medical condition while the certificate remains valid.
- 11. You should inform the police if you change your GP practice and provide contact details for the new practice.
- 12. You are asked to provide details of GP practices over the past 10 years and whether you have consulted medical practitioners other than at your GP practice so that all relevant information is available to police to assist with their assessment of suitability to possess a firearm certificate. Military personnel who are posted abroad and have a service GP may still be regarded as resident in the UK for the purposes of the application.

#### Convictions and offences

- 13. You must not withhold information about any conviction. This includes motoring offences (including speeding offences), bindovers, formal written cautions and convictions in and outside Great Britain, and (by virtue of the Rehabilitation of Offenders Act 1974 (Exceptions) Order 1975) convictions which are spent under the 1974 Act. A conditional discharge and an absolute discharge both count as convictions for this purpose. Details of parking offences and fixed penalty notices do not need to be declared.
- 14. Section 21 of the Firearms Act 1968 places restrictions on the possession of firearms and ammunition by those previously convicted of crime. A person receiving a sentence of imprisonment of three months or more is prohibited from possessing a firearm, shotgun, antique firearm, air weapon or ammunition for five years from the date of their release. In the case of a suspended sentence the prohibition applies from the second day after being sentenced. If the sentence is three years or more the prohibition applies for life unless lifted by the Crown (or Sheriff) Court.

#### Inspection of premises

 Please allow the police to inspect your guns and security when requested as in the absence of a warrant consent is required for the police to inspect premises.

#### **Photographs**

16. A digital photograph must be used for online applications. Paper applications must be accompanied by one photograph. Ordinary passport-style photographs (45mm high x 35mm wide) are suitable for this purpose. Photographs must be of a professional standard, against a plain cream or grey background and without other objects or people in the background and (if printed) must be on good quality gloss or matt paper. The photograph must be a true likeness and full face without a head covering (unless it is worn for religious or medical reasons). In your photograph you must be looking straight at the camera, have a neutral expression, with your eyes open and mouth closed. You must not wear sunglasses or tinted glasses, and the photographs must not have any 'red eye.'

#### Equality monitoring

17. The equality monitoring information you provide in Part H aims to assist the force in meeting its duties as a Public Authority. The information will be kept separately from the application.

#### Submission of application

18. The receipt for electronic applications, where these are available, will be automatically generated by the system. For hard copy applications, unless advised otherwise by the police, you should post or take the completed form together with the fee and photograph to the police firearms licensing department. In the case of an application for renewal, a signed and dated recent copy of the certificate to be renewed should be sent to police when you submit your application. If an application is being made for a variation the certificate to be varied must be included with your application. (You may wish to keep a copy of the certificate.)

#### Section 1 Firearms Only

- 19. To acquire or possess firearms or ammunition under Section 1 of the Firearms Act 1968, you have to provide evidence that you have a **good reason** to do so. This applies to the grant, renewal or variation of a firearm certificate. This evidence can take several forms: permission to shoot over land or membership of a target shooting club, or a booking or invitation to go deer stalking are examples, but these are not exhaustive.
- 20. Please provide the address of one area of land where you have permission to shoot, together with the name, address and telephone number of the person who has given you that permission or the details of a Home Office approved club of which you are a full member.
  NB: You will not necessarily be limited to shooting over that individual piece of land or at that club.

#### **EXPLANATORY NOTE**

(This note is not part of the Rules)

These Rules make a number of amendments to the Firearms Rules 1998 (S.I. 1998/1941).

Rules 3 and 5 amend the Firearms Rules 1998 in order to facilitate electronic applications for the grant, renewal or variation of both firearm and shotgun certificates where such applications are made in accordance with an approved electronic process. These amendments also provide that applications for the grant or renewal of such certificates need only be accompanied by one photograph of the applicant.

Rules 4 and 6 prohibit police and crime commissioners, their staff, members of the Scottish Police Authority and members of staff of the Scottish Police Authority from acting as a referee for an applicant for the grant or renewal of a firearm or shotgun certificate.

Rule 7 makes provision for the electronic submission of photographs of the applicant, and provides that an application made for both a firearm and a shotgun certificate need only be accompanied by one photograph.

Rule 8 replaces the existing prescribed forms for applications for the grant or renewal of a firearm or shotgun certificate and for applications to vary a firearm certificate.

Rules 9 and 10 make provision to enable chief officers to process applications which are made using the old forms that are to be replaced, provided that the application concerned is received on or before 28th February 2018.

A full impact assessment has not been produced for this instrument as no, or no significant, impact on the private, voluntary or public sector is foreseen.
