The Secretary of State makes the following Regulations in exercise of the powers conferred by sections 45B, 45F(2) and 45P(2) of the Public Health (Control of Disease) Act 1984(1).

## Citation, commencement, extent, application and interpretation

**1.**—(1) These Regulations may be cited as the Health Protection (Coronavirus, International Travel and Operator Liability) (England) (Amendment) (No. 22) Regulations 2021.

- (2) These Regulations come into force at 4.00 a.m. on 6th December 2021.
- (3) These Regulations extend to England and Wales and apply in relation to England only.

(4) In these Regulations, "the principal Regulations" means the Health Protection (Coronavirus, International Travel and Operator Liability) (England) Regulations 2021(**2**).

#### Amendments to the principal Regulations

**2.**—(1) The principal Regulations are amended as follows.

- (2) In Schedule 3, insert "Nigeria" at the appropriate place.
- (3) In paragraph 4 of Schedule 13, insert "Nigeria" at the appropriate place.

### **EXPLANATORY NOTE**

These Regulations amend the Health Protection (Coronavirus, International Travel and Operator Liability) (England) Regulations 2021 (S.I. 2021/582) ("the International Travel Regulations").

Regulation 2 adds Nigeria, respectively, to the list of category 3 countries and territories in Schedule 3 to the International Travel Regulations and the list of countries and territories in paragraph 4 of Schedule 13 to those Regulations.
