

## COMMISSION DECISION

of 21 December 1973

on the reimbursement by the Guidance Section of the EAGGF of expenditure incurred by the French Republic in respect of the first survey of orchards of certain species of fruit tree

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community ;

Having regard to Council Regulation (EEC) No 729/70 <sup>(1)</sup> of 21 April 1970 on the financing of the common agricultural policy, as last amended by Regulation (EEC) No 2788/72 <sup>(2)</sup>, and in particular Article 7 (1) thereof ;

Whereas the French Republic has applied for reimbursement in respect of the first survey carried out in pursuance of Council Directive (EEC) No 286/71 <sup>(3)</sup> of 26 July 1971 concerning the statistical surveys to be carried out by the Member States in order to determine the production potential of orchards of certain species of fruit tree ;

Whereas this application is in conformity with Commission Decision (EEC) No 186/73 <sup>(4)</sup> of 30 May 1973 concerning applications to the Guidance Section of the EAGGF for reimbursement in respect of the first survey of fruit tree orchards carried out in accordance with the Council Directive of 26 July 1971 ;

Whereas the results of the survey have been communicated to the Commission and have shown that the survey was carried out in accordance with Articles 1 to 4 of that Directive ;

Whereas the expenditure incurred in respect of the survey amounts, provided in the second line of Article

9 (2), to 352 954 units of account ; whereas the Guidance Section of the Fund should therefore, pursuant to Article 9 (2) of the Directive, bear 196 000 units of account of the expenditure incurred in respect of the survey ;

Whereas the Fund Committee has been consulted on the financial aspects, particularly as to the amount of the financial resources available,

HAS ADOPTED THIS DECISION :

*Article 1*

The contribution of the Guidance Section of the European Agricultural Guidance and Guarantee Fund towards the expenditure incurred in respect of the first survey of orchards of certain species of fruit tree carried out by the French Republic is fixed at 196 000 units of account.

*Article 2*

This Decision is addressed to the French Republic.
