

**COMMISSION DECISION**

of 17 March 1977

**approving the transport of certain quantities of beef carried out by the French intervention agency prior to 1 January 1977**

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,

Having regard to Council Regulation (EEC) No 729/70 of 21 April 1970 on the financing of the common agricultural policy<sup>(1)</sup>, as last amended by Regulation (EEC) No 2788/72<sup>(2)</sup>,

Having regard to Council Regulation (EEC) No 2305/70 of 10 November 1970 on the financing of intervention expenditure in respect of the internal market in beef and veal<sup>(3)</sup>, as last amended by Regulation (EEC) No 565/77<sup>(4)</sup>, and in particular Article 3 (1) (h) thereof,

Whereas, in accordance with Articles 1, 2 (1) and 3 (1) (h) of Regulation (EEC) No 2305/70, the costs incurred in transporting certain meat held by the intervention agencies are chargeable to the Guarantee Section of the European Agricultural Guidance and Guarantee Fund;

Whereas the French Republic notified the Commission of the reasons for the transport in 1974, 1975 and 1976 of 142 406 tonnes of beef taken over by its intervention agency and requested approval for such transport; whereas the reasons given by the French Republic justify the approval of such transport in 1974, 1975 and 1976 of 142 406 tonnes of beef taken over by the French intervention agency;

Whereas the measures provided for in this Decision are in accordance with the opinion of the Management Committee for Beef and Veal,

HAS ADOPTED THIS DECISION:

*Article 1*

In accordance with Article 3 (1) (h) of Regulation (EEC) No 2305/70, approval is hereby granted for the transport of the following quantities of beef taken over by the French intervention agency:

- (a) for 1974: 56 881 tonnes of bone-in meat,  
2 707 tonnes of boned meat,
- (b) for 1975: 36 419 tonnes of bone-in meat,  
11 447 tonnes of boned meat,
- (c) for 1976: 34 918 tonnes of bone-in meat,  
34 tonnes of boned meat.

*Article 2*

This Decision is addressed to the French Republic.
