COMMISSION DECISION

of 20 December 1983

fixing maximum amounts for contracts awarded under the tendering procedure opened by Regulation (EEC) No 3119/83 on the supply of various lots of skimmed-milk powder as food aid

(83/660/EEC)

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,

Having regard to Council Regulation (EEC) No 804/68 of 27 June 1968 on the common organization of the market in milk and milk products (1), as last amended by Regulation (EEC) No 1600/83 (2), and in particular Article 7 (5) thereof,

Whereas, under Commission Regulation (EEC) No 3119/83 of 31 October 1983 on the supply of various lots of skimmed-milk powder as food aid (3), tenders have been invited for the supply of 5 250 tonnes of skimmed-milk powder to certain third countries and certain organizations;

Whereas Article 13 (1) of Commission Regulation (EEC) No 1354/83 of 17 May 1983 laying down general rules for the mobilization and supply of skimmed-milk powder, butter and butteroil as food aid (*), as amended by Regulation (EEC) No 1886/83 (5), specifies that in the light of the tenders received a maximum amount shall be fixed for each lot, or part thereof if the third subparagraph of Article 11 (3) is used, or a decision shall be taken to make no award;

Whereas on the basis of the tenders received the maximum amounts should be those specified below;

Whereas the measures provided for in this Decision are in accordance with the opinion of the Management Committee for Milk and Milk Products,

HAS ADOPTED THIS DECISION:

Article 1

The maximum amounts to be adhered to when awards are made under the tendering procedure opened by Regulation (EEC) No 3119/83 shall be:

— Lot D: 1 113 816 ECU (B) — Lot L: 847 613 ECU (B) — Lot N: 922 176 ECU (B) — Lot Q: 382 111 ECU (IRL) — Lot AE: 1 139 460 ECU (B) 1 304 922 ECU (B) — Lot AP: 848 793 ECU (D) — Lot AQ: 850 170 ECU (D) 853 414 ECU (D) 855 381 ECU (D)

In the case of Lots F and R, no award shall be made.

Article 2

This Decision is addressed to the Member States.
