

COMMISSION DECISION

of 20 March 1984

fixing maximum amounts for contracts awarded under the tendering procedure opened by Regulation (EEC) No 496/84 on the supply of various lots of skimmed-milk powder as food aid

(84/176/EEC)

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,

Having regard to Council Regulation (EEC) No 804/68 of 27 June 1968 on the common organization of the market in milk and milk products⁽¹⁾, as last amended by Regulation (EEC) No 1600/83⁽²⁾, and in particular Article 5 (7) thereof,

Whereas, under Commission Regulation (EEC) No 496/84 of 27 February 1984 on the supply of various lots of skimmed-milk powder as food aid⁽³⁾, tenders have been invited for the supply of 10 141 tonnes of skimmed-milk powder to certain third countries and certain organizations;

Whereas Article 13 (1) of Commission Regulation (EEC) No 1354/83 of 17 May 1983 laying down general rules for the mobilization and supply of skimmed-milk powder, butter and butteroil as food aid⁽⁴⁾, as amended by Regulation (EEC) No 1886/83⁽⁵⁾, specifies that in the light of the tenders received a maximum amount shall be fixed for each lot, or part thereof if the third subparagraph of Article 11 (3) is used, or a decision shall be taken to make no award;

Whereas, on the basis of the tenders received, the maximum amounts should be those specified below;

Whereas the measures provided for in this Decision are in accordance with the opinion of the Management Committee for Milk and Milk Products,

HAS ADOPTED THIS DECISION:

Article 1

The maximum amounts to be adhered to when awards are made under the tendering procedure opened by Regulation (EEC) No 496/84 shall be:

— lot C:	800 123 ECU (D)
— lot G:	1 218 372 ECU (D)
— lot H:	901 567 ECU (D)
— lot I:	723 987 ECU (N)
— lot K:	609 166 ECU (D)
— lot L:	606 531 ECU (D)
— lot M:	853 542 ECU (N)
— lot N:	2 362 482 ECU (N)
— lot O:	1 043 022 ECU (B)
— lot P:	570 765 ECU (D)
— lot Q:	151 157 ECU (D)
— lot R:	2 924 ECU (D)
— lot T:	742 054 ECU (IRL)
— lot U:	393 082 ECU (B)
— lot X:	14 342 ECU (D)
— lot Y:	381 731 ECU (B)

In the case of lots A, B, D, E and F no award shall be made.

This Decision is addressed to the Member States.
