

## COMMISSION DECISION

of 30 November 1984

fixing maximum amounts for contracts awarded under the tendering procedure  
opened by Regulation (EEC) No 3145/84 on the supply of various lots of  
skimmed-milk powder as food aid

(84/630/EEC)

THE COMMISSION OF THE EUROPEAN  
COMMUNITIES,

Having regard to the Treaty establishing the European  
Economic Community,

Having regard to Council Regulation (EEC) No 804/68  
of 27 June 1968 on the common organization of the  
market in milk and milk products <sup>(1)</sup>, as last amended  
by Regulation (EEC) No 1557/84 <sup>(2)</sup>, and in particular  
Article 7 (5) thereof,

Whereas, under Commission Regulation (EEC) No  
3145/84 of 8 November 1984 on the supply of various  
lots of skimmed-milk powder as food aid <sup>(3)</sup>, tenders  
have been invited for the supply of 4 805 tonnes of  
skimmed-milk powder to certain third countries and  
beneficiary organizations ;

Whereas Article 13 (1) of Commission Regulation  
(EEC) No 1354/83 of 17 May 1983 laying down  
general rules for the mobilization and supply of  
skimmed-milk powder, butter and butteroil as food  
aid <sup>(4)</sup>, as amended by Regulation (EEC) No  
1886/83 <sup>(5)</sup>, specifies that in the light of the tenders  
received a maximum amount shall be fixed for each  
lot, or part thereof if the third subparagraph of Article  
11 (3) is used, or a decision shall be taken to make no  
award ;

Whereas on the basis of the tenders received the  
maximum amounts should be those specified below ;

Whereas the measures provided for in this Decision  
are in accordance with the opinion of the Management  
Committee for Milk and Milk Products,

HAS ADOPTED THIS DECISION :

*Article 1*

The maximum amounts to be adhered to when awards  
are made under the tendering procedure opened by  
Regulation (EEC) No 3145/84 shall be :

— Lot I :	115 978 ECU (D)
— Lot K :	12 096 ECU (D)

— Lot L :	10 377 ECU (D)

— Lot M :	13 325 ECU (D)
	13 431 ECU (D)
