COMMISSION DECISION of 22 December 1999

amending Decision 1999/354/EC on the eligibility of expenditure to be incurred by certain Member States in 1999 for the purpose of introducing monitoring and control systems applicable to the fisheries policy

(notified under document number C(1999) 4845)

(2000/102/EC)

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Community,

Having regard to Council Decision 95/527/EC of 8 December 1995 on a Community financial contribution towards certain expenditure incurred by the Member States in implementing the monitoring and control systems applicable to the common fisheries policy (¹), and in particular Article 6 thereof,

ture eligible for a financial contribution under that Decision.

(5) The measures provided for in this Decision are in accordance with the opinion of the Management Committee for Fisheries and Aquaculture,

HAS ADOPTED THIS DECISION:

Article 1

Decision 1999/354/EC is amended as follows:

- (1) The available appropriations may be committed in order to satisfy many of the Member States' requests which could not be accepted at the time of adoption of Commission Decision 1999/354/EC on the eligibility of expenditure to be incurred by certain Member States in 1999 for the purpose of introducing monitoring and control systems applicable to the common fisheries policy (²).
 - (2) Some Member States have informed the Commission under Article 8 of Decision 95/527/EC that part of their eligible expenditure will not be incurred in 1999.
 - (3) Decision 1999/354/EC should therefore be amended accordingly.
 - (4) Greece has forwarded additional information concerning its requests for a financial contribution towards the expenditure referred to in Article 2 of Decision 95/527/EC for 1999 which will affect the amount of expendi-
