

Council Directive of 26 June 1964 on animal health problems affecting  
intra-Community trade in bovine animals and swine (64/432/EEC)

*[<sup>F1</sup>Article 1*

This Directive shall apply to intra-Community trade in bovine animals and swine with the exception of feral pigs as defined in Article 2 (e) of Directive 80/217/EEC<sup>(1)</sup> without prejudice to the provisions laid down in Directives 80/215/EEC<sup>(2)</sup>, 85/511/EEC, 88/407/EEC<sup>(3)</sup>, 89/608/EEC<sup>(4)</sup>, 90/425/EEC, 90/429/EEC<sup>(5)</sup>, 90/667/EEC<sup>(6)</sup>, 91/496/EEC, 91/628/EEC<sup>(7)</sup>, 92/102/EEC<sup>(8)</sup>, 92/119/EEC and Decision 90/424/EEC<sup>(9)</sup>.]
