REGULATION No 213/67/EEC OF THE COUNCIL

of 27 June 1967

establishing the list of representative markets for pigmeat in the Community

THE COUNCIL OF THE EUROPEAN ECONOMIC COMMUNITY,

Having regard to the Treaty establishing the European Economic Community;

Having regard to Council Regulation No 121/67/EEC¹ of 13 June 1967 on the common organisation of the market in pigmeat, and in particular Article 4 (5) thereof;

Having regard to the proposal from the Commission;

Whereas under the provisions of Article 4 (2) of Regulation No 121/67/EEC intervention measures may be taken if, on the representative markets of the Community, the average price for pig carcasses is, and is likely to remain, below the basic price;

Whereas the list of representative markets must be established to enable those provisions to be applied;

Whereas, in the light of recent experience, the markets or groups of markets with reference to which prices for pig carcasses have until now been determined should in the first instance be designated as representative markets; whereas, however, such experience suggests that other markets should also be

designated for Belgium; whereas, moreover, in the case of the Netherlands, the places where purchasing organisations are situated by reference to which purchase prices are determined by these organisations should be taken into account;

Whereas the list of representative markets should be re-examined with a view to fixing, in accordance with the provisions of Article 4 of Regulation No 121/67/EEC, the basic price valid from 1 November 1968; whereas the period of validity of this Regulation should therefore be limited to 31 October 1968;

HAS ADOPTED THIS REGULATION:

Article 1

The representative markets within the meaning of Article 4 (2) of Regulation No 121/67/EEC shall be the six markets listed in the Annex.

Article 2

This Regulation shall enter into force on 1 July 1967.

It shall be applicable until 31 October 1968.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
