REGULATION (EEC) No 1892/68 OF THE COUNCIL

of 26 November 1968

making additional provisions for the financing of the common agricultural policy in respect of sugar

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community, and in particular Articles 43 and 200 (3) thereof;

Having regard to the proposal from the Commission;

Having regard to the Opinion of the European Parliament¹;

Whereas Article 43 (4) of Council Regulation No 1009/67/EEC² of 18 December 1967 on the common organization of the market in sugar provides for the establishment of the financial system relating to the contributions provided for in Articles 8 (1) and 27 (1) and the amounts provided for in Article 25 (3) thereof;

Whereas by reason, on the one hand, of the expenditure in respect of the market in sugar devolving on the European Agricultural Guidance and Guarantee Fund and, on the other, of the relationship between the system giving rise to that expenditure and the abovementioned contributions and amounts, revenue from those amounts and contributions should be treated in relation to the Fund in the same way as levies; whereas, therefore, in accordance with Article 200 (3) of the Treaty, those contributions and amounts should be included in the calculation of the first part of the contributions from Member States referred to in Article 11 of Council Regulation No 130/66/EEC³ of 26 July 1966 on the financing of the common agricultural policy, as amended by Regulation No 741/67/EEC⁴;

Whereas application of the provisions resulting from the foregoing considerations should be limited to the period ending on 31 December 1969,

HAS ADOPTED THIS REGULATION:

Article 1

The first part of the contributions from Member States referred to in Article 11 (1) and (2) of Regulation No 130/66/EEC shall include 90% of the total amount of the contributions provided for in Articles 8 and 27 of Regulation No 1009/67/EEC and of the amounts laid down in Article 25 thereof, collected by the Member States during the accounting period in question.

Article 2

Article 9 of Council Regulation No 17/64/EEC⁵ of 5 February 1964 on the conditions for granting aid from the European Agricultural Guidance and Guarantee Fund, as last amended by Regulation (EEC) No 347/68⁶, shall be supplemented by the following paragraph:

'3a - A statement in respect of the contributions provided for in Articles 8 and 27 of Regulation No 1009/67/EEC and of the amounts laid down in Article 25 thereof shall also be attached to each application referred to in paragraph 2.'

Article 3

This Regulation shall enter into force on the third day following its publication in the *Official Journal of the European Communities*.

It shall be applied until 31 December 1969.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
