## REGULATION (EEC) No 2683/70 OF THE COMMISSION

of 29 December 1970

laying down special procedures for the advance fixing of export refunds on milk and milk products

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community;

Having regard to Council Regulation (EEC) No 804/68<sup>1</sup> of 27 June 1968 on the common organisation of the market in milk and milk products, as last amended by Regulation (EEC) No 1253/70,<sup>2</sup> and in particular Article 17 (4) thereof;

Whereas the Annex to Commission Regulation (EEC) No 1100/68<sup>3</sup> of 26 July 1968 laying down detailed rules of application for the advance fixing of export refunds on milk and milk products, as last amended by Regulation (EEC) No 1522/70,<sup>4</sup> lists the products for which export refunds may not be fixed in advance when exported to certain destinations; whereas Regulation (EEC) No 2307/70<sup>5</sup> amending Council Regulation (EEC) No 823/68<sup>6</sup> of 28 June 1968 determining the groups of products and the special provisions for calculating levies on milk and milk products amends the nomenclature of the Common Customs Tariff with effect from 1 January 1971; whereas the Annex to Regulation (EEC) No 1100/68 must therefore be amended;

Whereas Commission Regulation (EEC) No 2637/70<sup>7</sup> of 23 December 1970 on special detailed rules for the application of the system of import and export licences and advance fixing certificates for agricultural products repeals, with effect from 1 January 1971, Articles 2, 3 and 5 of Regulation (EEC) No 1100/68; whereas the articles of that Regulation remaining in

force, Articles 1, 4 and 6, should be repealed for the sake of clarity and a new Regulation promulgated;

Whereas the measures provided for in this Regulation are in accordance with the Opinion of the Management Committee for Milk and Milk Products.

HAS ADOPTED THIS REGULATION:

*Article 1*

The refund shall, on application, be fixed in advance for products covered by Article 1 of Regulation (EEC) No 804/68, except for those set out in the Annex to this Regulation when exported to the destinations indicated.

*Article 2*

The adjustments to be made to the refunds fixed in advance, pursuant to the provisions of the third subparagraph of Article 5 (3) of Regulation (EEC) No 876/68, shall be made in accordance with a list to be drawn up.

*Article 3*

Regulation (EEC) No 1100/68 is hereby repealed.

*Article 4*

This Regulation shall enter into force on 1 January 1971.
