

REGULATION (EEC) No 2854/71 OF THE COMMISSION

of 29 December 1971

amending, as regards tariff nomenclature for pigmeat, Regulations No 204/67/EEC and (EEC) Nos 2403/69, 2275/71 and 2630/71

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community;

Having regard to Council Regulation No 121/67/EEC¹ of 13 June 1967 on the common organisation of the market in pigmeat, as last amended by Regulation (EEC) No 2727/71,² and in particular Articles 8, 10 (4) and 12 (1), the first subparagraph of Article 15 (5) and Article 15 (6) thereof;

Whereas the tariff nomenclature was amended, in particular with regard to headings Nos 02.05 and 15.01 A of the Common Customs Tariff, by Council Regulation (EEC) No 2727/71 of 20 December 1971; whereas, this has given rise in certain cases to an amended tariff classification for pigmeat products;

Whereas Commission Regulation No 204/67/EEC³ of 28 June 1967, as last amended by Regulation (EEC) No 1620/71,⁴ Commission Regulation (EEC) No 2275/71⁵ of 25 October 1971, Commission Regulation (EEC) No 2403/69⁶ of 1 December 1969, as last amended by Regulation (EEC) No 1438/70,⁷ and Commission Regulation (EEC) No 2630/71⁸ of 10 December 1971 must therefore be adapted;

Whereas the measures provided for in this Regulation are in accordance with the Opinion of the Management Committee for Pigmeat;

HAS ADOPTED THIS REGULATION:

Article 1

1. In Annex 1 to Regulation No 204/67/EEC, Annexes A and B to Regulation (EEC) No 2275/71 and in the Annex to Regulation (EEC) No 2630/71, the following shall be substituted for the description of goods falling within heading No 02.05 of the Common Customs Tariff:

'Pig fat free of lean meat and poultry fat (not rendered or solvent-extracted), fresh, chilled, frozen, salted, in brine, dried or smoked.'

2. In Annex I to Regulation No 204/67/EEC, Annexes A, B and C to Regulation (EEC) No 2275/71, Annex I to Regulation (EEC) No 2403/69 and in the Annex to Regulation (EEC) No 2630/71, the following shall be substituted for the description of goods falling within heading No 15.01 of the Common Customs Tariff:

'Lard, other pig fat and poultry fat, rendered or solvent-extracted.'

Article 2

This Regulation shall enter into force on 1 January 1972.
