REGULATION (EEC) No 2712/72 OF THE COUNCIL
of 19 December 1972

fixing the guide prices for fishery products listed in Annex II of Regulation (EEC) No 2142/70 for the 1973 fishing year

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty of the European Economic Community;

Having regard to Regulation (EEC) No 2142/70¹ of the Council of 20 October 1970 on the common organisation of the market in fishery products as last amended by the Act² annexed to the Treaty concerning the Accession of new Member States to the European Economic Community and the European Atomic Energy Community, signed at Brussels on 22 January 1972, and in particular Article 13 (5) thereof;

Having regard to the proposal from the Commission;

Whereas Article 13 (1) of Regulation (EEC) No 2142/70 provides that guide prices shall be fixed annually for each of the products or groups of products listed in Annex II of that Regulation;

Whereas the guide prices of the fishery products listed in Annex II of Regulation (EEC) No 2142/70 were fixed for the first time by Regulation (EEC) No 168/71³; whereas they were maintained at the same level for the 1972

fish marketing year by Regulation (EEC) No 2656/71⁴;

Whereas the data available at present concerning the prices leads, in relation to the majority of products concerned, to an increase in the guide prices in relation to those valid during the preceding marketing year,

HAS ADOPTED THIS REGULATION:

Article 1

The guide prices for products listed in Annex II of Regulation (EEC) No 2142/70 and the products to which they relate are specified in the Annex hereto. These prices shall be valid until 31 December 1973.

Article 2

This Regulation shall enter into force on 1 January 1973.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
