

REGULATION (EEC) No 2665/75 OF THE COMMISSION
of 20 October 1975

altering the frequency of partial invitations to tender for the export of sugar
under Regulation (EEC) No 2101/75

THE COMMISSION OF THE EUROPEAN
COMMUNITIES,

Having regard to the Treaty establishing the European
Economic Community ;

Having regard to Council Regulation (EEC) No
3330/74⁽¹⁾ of 19 December 1974 on the common
organization of the market in sugar, as amended by
Regulation (EEC) No 2623/75⁽²⁾, and in particular
Article 19 (4) thereof ;

Having regard to Council Regulation (EEC) No
608/72⁽³⁾ of 23 March 1972 laying down rules to be
applied in the case of considerable price rises on the
world sugar market, and in particular Article 1 (1)
thereof ;

Whereas under Commission Regulation (EEC) No
2101/75 of 11 August 1975⁽⁴⁾ on a standing invitation
to tender in order to determine a levy and/or refund
on exports of white sugar the Member States are to
issue weekly partial invitations to tender for the export
of sugar from the marketing year 1975/76 ; whereas,
having regard in particular to production forecasts of
the said marketing year provision should be made to
increase the interval between partial invitations to
tender ;

Whereas the measures provided for in this Regulation
are in accordance with the Opinion of the Manage-
ment Committee for Sugar,

HAS ADOPTED THIS REGULATION :

Article 1

The word 'weekly' in Article 1 of Regulation (EEC)
No 2101/75 shall be deleted.

This Regulation shall be binding in its entirety and directly applicable in all Member
States.

Done at Brussels, 20 October 1975.

Article 2

Article 4 (1), (2) and (3) of Regulation (EEC) No
2101/75 shall be replaced by the following :

Article 4

1. The period during which tenders may be
submitted in response to the first partial invitation
to tender after 21 October 1975 shall begin on
that day and shall end on Wednesday 29 October
1975 at 10 a.m.
2. The period during which tenders may be
submitted in response to the subsequent partial
invitations :
 - (a) shall begin on the first working day following
the end of the previous period ;
 - (b) shall end at 10 a.m. on the second Wednesday
following the end of the previous week.
3. By way of derogation from paragraph 2 no
partial invitation to tender will take place on
Wednesday 24 December 1975.

Article 3

This Regulation shall enter into force on 21 October
1975.
