

COMMISSION REGULATION (EEC) No 2959/77

of 23 December 1977

amending the Annex to Regulation (EEC) No 2518/70 as regards the fixing of the representative wholesale markets or ports for fishery products

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,

Having regard to Council Regulation (EEC) No 100/76 of 19 January 1976 on the common organization of the market in fishery products⁽¹⁾, as amended by Regulation (EEC) No 2429/76⁽²⁾, and in particular Article 10 (3) thereof,

Whereas the wholesale markets or ports in Member States to be considered as representative for a specific product should be those where a significant proportion thereof is marketed;

Whereas the list of representative wholesale markets or ports was laid down in Commission Regulation (EEC) No 2518/70 of 10 December 1970 on price recording and fixing the list of representative wholesale markets or ports for fishery products⁽³⁾, as last amended by Regulation (EEC) No 712/77⁽⁴⁾;

Whereas, because of the changes which have occurred on Community markets, it is necessary to add to the list of representative wholesale markets or ports certain ports at which significant quantities of redfish, cod, saithe, haddock and mackerel are landed;

Whereas the measures provided for in this Regulation are in accordance with the opinion of the Management Committee for Fishery Products,

HAS ADOPTED THIS REGULATION :

Article 1

Part I, (3), (4), (5), (6) and (8) of the Annex to Regulation (EEC) No 2518/70 is amended to read as follows :
