Modification, suspension and revocation of authorisations

- 1 The authorisation holder may, in accordance with the procedure laid down in Article 7, apply for a modification of the existing authorisation.
- ^{F1}... The Authority shall deliver an opinion on whether an authorisation is still in accordance with this Regulation, following the procedure laid down in Article 8, where applicable.
- [F23] The appropriate authority must examine the opinion of the Authority without delay and take the decision whether to modify the entry for that authorisation.]
- [F34] Where the appropriate authority decides to modify the entry for that authorisation it must prescribe the modification of the entry for that product on the list and amend Regulation 1321/2013.]
