amending Regulation (EC) No 1159/2009 fixing the import duties in the cereals sector applicable from 1 December 2009

## THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Council Regulation (EC) No 1234/2007 of 22 October 2007 establishing a common organisation of agricultural markets and on specific provisions for certain agricultural products (Single CMO Regulation)<sup>(1)</sup>,

Having regard to Commission Regulation (EC) No 1249/96 of 28 June 1996 laying down detailed rules for the application of Council Regulation (EEC) No 1766/92 in respect of import duties in the cereals sector<sup>(2)</sup>, and in particular Article 2(1) thereof,

# Whereas:

- (1) The import duties in the cereals sector applicable from 1 December 2009 were fixed by Commission Regulation (EC) No 1159/2009<sup>(3)</sup>.
- (2) As the average of the import duties calculated differs by more than EUR 5/tonne from that fixed, a corresponding adjustment must be made to the import duties fixed by Regulation (EC) No 1159/2009.
- (3) Regulation (EC) No 1159/2009 should therefore be amended accordingly,

#### HAS ADOPTED THIS REGULATION:

### Article 1

Annexes I and II to Regulation (EC) No 1159/2009 are hereby replaced by the text in the Annex to this Regulation.

#### Article 2

This Regulation shall enter into force on the day of its publication in the *Official Journal* of the European Union.

It shall apply from 9 December 2009.

This Regulation shall be binding in its entirety and directly applicable in all Member States.

  - 2 EUR/t, where the port of unloading is in Denmark, Estonia, Ireland, Latvia, Lithuania, Poland, Finland, Sweden, the United Kingdom or the Atlantic coast of the Iberian peninsula.
- The importer may benefit from a flatrate reduction of EUR 24 per tonne where the conditions laid down in Article 2(5) of Regulation (EC) No 1249/96 are met.
