

Regulation (EU) No 305/2011 of the European Parliament and of the Council of 9 March 2011 laying down harmonised conditions for the marketing of construction products and repealing Council Directive 89/106/EEC (Text with EEA relevance)

CHAPTER VII

[^{F1}APPROVED BODIES]

Article 49

Identification numbers and lists of [^{F1}approved] bodies

1 The [^{F2}Secretary of State] shall assign an identification number to each [^{F3}approved] body.

It shall assign a single such number even where the body is [^{F3}approved] under several [^{F4}relevant enactments].

2 The [^{F5}Secretary of State] shall make publicly available the list of [^{F6}approved bodies], including the identification numbers that have been allocated to them and the activities for which they have been [^{F7}approved.]

The [^{F8}Secretary of State] shall ensure that this list is kept up-to-date.

[^{F9}3 The Secretary of State may authorise the UK national accreditation body to compile and maintain the list referred to in paragraph 2.]
