#### CHAPTER I

## SUBJECT MATTER, SCOPE AND DEFINITIONS

#### Article 4

## Vehicle categories

1 For the purposes of this Regulation, the following vehicle categories shall apply:

Category M consists of motor vehicles designed and constructed primarily for the carriage of passengers and their luggage, divided into:

> motor vehicles with not more than eight seating positions Category in addition to the driver's seating position and without  $M_1$ space for standing passengers, regardless of whether the number of seating positions is restricted to the driver's seating position;

> motor vehicles with more than eight seating positions (ii) in addition to the driver's seating position and having Category  $M_2$ a maximum mass not exceeding 5 tonnes, regardless of whether those motor vehicles have space for standing

passengers; and

motor vehicles with more than eight seating positions (iii) in addition to the driver's seating position and having Category  $M_3$ a maximum mass exceeding 5 tonnes, regardless of whether those motor vehicles have space for standing

passengers;

Category N consists of motor vehicles designed and constructed primarily for the carriage of goods, divided into:

> motor vehicles with maximum mass not

Category exceeding 3,5 tonnes;

vehicles (ii) motor with a maximum mass Category exceeding 3,5 tonnes but not exceeding 12 tonnes; and  $N_2$ 

(iii) vehicles with maximum motor a mass

Category exceeding 12 tonnes;

Category O consists of trailers, divided into:

trailers with a maximum mass not exceeding 0,75 tonnes;
