## CHAPTER VIII

### VEHICLES PRODUCED IN SMALL SERIES

#### *Article 41*

#### **[<sup>F1</sup>GB] type-approval of vehicles produced in [<sup>F2</sup>medium] series**

1 At the request of the manufacturer and within the quantitative annual limits for vehicle categories M, N and O set out in point 1 of Part A of Annex V, [<sup>F3</sup>the approval authority] shall grant [<sup>F4</sup>a GB] type-approval for a type of vehicle produced in [<sup>F5</sup>medium] series that satisfies at least the technical requirements laid down in Appendix 1 to Part I of Annex II.

2 Paragraph 1 shall not apply to special purpose vehicles.

3 The [<sup>F6</sup>GB] type-approval certificate for vehicles produced in [<sup>F7</sup>medium] series shall be given a unique number in accordance with a <sup>F8</sup>... numbering system, which shall at least allow for <sup>F9</sup>... the identification of the requirements to which the type of vehicle, system, component or separate technical unit conforms.

4 The [<sup>F10</sup>Secretary of State may by regulations lay] down the template and the numbering system for [<sup>F11</sup>GB] type-approval certificates for vehicles produced in [<sup>F12</sup>medium] series. <sup>F13</sup>...

[<sup>F14</sup>5 The Secretary of State may by regulations amend—

- a Appendix I of Part I to Annex II to set out the technical requirements for vehicle categories M, N and O, and
- b point 1 of Part A of Annex V accordingly as regards the quantitative annual limits.]

## Article 42

### <sup>F15</sup> ... Type-approval of vehicles produced in small series

1 Manufacturers may apply for a <sup>F16</sup>... type-approval of vehicles produced in small series within the quantitative annual limits set out in point 2 of Part A of Annex V. Those limits shall apply to the making available on the market, the registration or the entry into service of vehicles of the approved type [<sup>F17</sup>in Great Britain] in a given year.

2 [<sup>F18</sup>The approval authority] may decide to exempt any type of vehicle referred to in paragraph 1 from the obligation to comply with one or more of the requirements of this Regulation or with one or more of the requirements laid down in the regulatory acts listed in Annex II, provided that [<sup>F19</sup>the vehicle type satisfies the relevant alternative requirements specified in Schedule 1 to the Road Vehicles (Approval) Regulations 2020].

3 For the <sup>F16</sup>... type-approval of vehicles produced in small series, the approval authority shall accept systems, components and separate technical units that are type-approved in accordance with the regulatory acts listed in Annex II.

4 The <sup>F16</sup>... type-approval certificate for vehicles produced in small series shall be given a unique number in accordance with a <sup>F20</sup>... numbering system, which shall at least allow for <sup>F21</sup>... characterising the approval as one granted for a <sup>F16</sup>... small series.
