An Act for continuing for Twenty-one Years, and from thence to the End of the then next Session of Parliament, the Term and Powers of Two Acts, passed in the Thirtieth Year of the Reign of His late Majesty King *George* the Second, and the Eighteenth Year of the Reign of His present Majesty, for amending, widening, and keeping in Repair, the Roads from the East End of the Town of *Hertford*, in the County of *Hertford*, through *Watton*, to *Broadwater*, and from the Town of *Ware*, through *Watton*, to the North End of the Town of *Walkern*, in the said County.

WHEREAS Two Acts were made in the Thirtieth Year of the Reign of His late Majesty King *George* the Second, and the Eighteenth Year of the Reign of His present Majesty, for amending, widening, and keeping in Repair, the Roads from the East End of the Town of *Hertford*, in the County of *Hertford*, through *Watton*, to *Broadwater*, and from the Town of *Ware*, through *Watton*, to the North End of the Town of *Walkern*, in the said County: And whereas a considerable Sum of Money hath been borrowed, and is now due and owing, on the Credit of the Tolls authorized to be collected

upon the said Roads; which Money cannot be paid off, and the said Roads effectually amended and kept in Repair, unless the Term and Powers of the said Acts are enlarged: May it therefore please Your Majesty that it may be enacted; and be it enacted by the King's most Excellent Majesty, by and with the Advice and Consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the Authority of the same, That the Term granted by the said recited Acts shall be repealed; and that the said recited Acts, and the several Clauses, Tolls, Powers, Provisions, Exemptions, Matters, and Things, therein contained, and which are now in Force, (except such as relate to Exemption from Stamp Duties), and also this present Act, shall be, and are hereby declared to be in full Force and Effect, and shall have Continuance for and during the further Term herein-after mentioned, as fully and effectually to all Intents and Purposes as if the same were herein particularly inserted, repeated, and re-enacted; and that this Act, and the additional Term hereby granted, shall be subject and liable to the Payment of all Monies now due and owing, or which shall be borrowed; on the Credit of the said recited Acts, and this present Act, and of all Interest due or to grow due thereon respectively.

II. And be it further enacted, That all the Costs, Charges, and Expences incident to and attending the obtaining and passing of this Act, shall be paid out of any Money already collected or received, or to be collected or received, by virtue of the said recited Acts, and this Act.

Publick Act.

III. And be it further enacted, That this Act shall be deemed, adjudged, and taken to be a Publick Act; and shall be judicially taken Notice of as such, by all Judges, Justices, and other Persons whomsoever, without specially pleading the same.

Continuance
of the Act.

IV. And be it further enacted, That this Act shall commence and take place upon the *Monday* Fortnight next after the passing thereof, and, together with the said recited Acts, shall continue in Force for and during the Term of Twenty-one Years, and from thence to the End of the then next Session of Parliament.
