[^{F1}Appeals to the Care Tribunal

15.—(1) A person may appeal to the Care Tribunal against a relevant decision.

(2) On the appeal, the Care Tribunal may—

- (a) confirm the decision,
- (b) set aside the decision [^{F2}or, in ^{F3}... amended] , or
- (c) substitute for the decision appealed against any other decision that could have been made.

(3) “Relevant decision” means—

- (a) a decision under this Part in respect of registration, ^{F4}...
