CHAPTER 1

EMPLOYERS' DUTIES

*Supplementary provision about the duties*

**Information to be given to workers**

- 10.**—(1) The Department [<sup>F1</sup>may] make provision by regulations—
- (a) for <sup>F2</sup>... jobholders to be given information about the effect of sections 2 to 8 in relation to them;
  - (b) for <sup>F3</sup>... workers to whom section 9 applies to be given information about the effect of that section in relation to them;
  - (c) for a prescribed person to be required to provide the information.
- (2) Regulations under this section [<sup>F4</sup>may in particular make provision about] —
- (a) what information must be given;
  - (b) in what circumstances it must be given;
  - (c) how and when it must be given.
