PROSPECTIVE

Operator's licence [^{F1}conditions relating to] separate fares **N.I.**

8 An operator's licence may—

- ^{F2}(a)
- (b) be subject to the condition that only taxis of such class as may be specified in the licence may be used for or in respect of the operation of [^{F3}a taxi service for or in respect of the carriage of passengers at separate fares] ;
- (c) be subject to such other conditions as may be prescribed and such other conditions as the Department may think fit relating to the carrying of passengers at separate fares.
