**Financial Provisions (Northern Ireland) Order 1976**

**Title and Commencement**

1.—(1) This Order may be cited as the Financial Provisions (Northern Ireland) Order 1976.

(2) *Commencement*

**Interpretation**

2.—(1) The Interpretation Act (Northern Ireland) 1954 shall apply to Article 1 and the following provisions of this Order as it applies to a Measure of the Northern Ireland Assembly.

(2) In this Order the expression “statutory provision” has the meaning assigned to it by section 1(f) of the Interpretation Act (Northern Ireland) 1954.

**Fee for certificate of birth, marriage<sup>[F1]</sup>, civil partnership<sup>[F1]</sup> or death for purposes of certain Acts**

15.—<sup>[F2]</sup>(1<sup>[F2]</sup>) The fee payable under section 10 of the Savings Banks Act 1887 for the issue of a certificate of birth, marriage<sup>[F1]</sup>, civil partnership<sup>[F1]</sup> or death for the purposes of the Acts relating to the National Savings Bank,<sup>[F3]</sup> ... and government annuities shall be 5p or such larger sum as the<sup>[F2]</sup> Department of Finance and Personnel may by order prescribe<sup>[F2]</sup> and, accordingly, ... *residue amends s.10 of 1887 c.40*

<sup>[F2]</sup>(2) No order shall be made under paragraph (1) unless a draft of the order has been laid before and approved by resolution of the Assembly.<sup>[F2]</sup>
