**The registers**

6.—<sup>F1</sup>(1) In relation to the registers mentioned in sub-paragraphs (a), (b) and (c) there shall continue to be kept<sup>F2</sup>... in accordance with the succeeding provisions of this Order,—

(a) a register of pharmaceutical chemists;

(b) a register of druggists; <sup>F3</sup>and]

(c) a register of students; <sup>F4</sup>...

<sup>F4</sup>(d) .....]

(2) Registration under this Order shall not entitle any person so registered to practice medicine or surgery or any branch of medicine or surgery.
