The Department(a) of Commerce, in exercise of the powers conferred on it by section 9(1)(a) of the Statistics of Trade Act (Northern Ireland) 1949(b) (as inserted by section 2 of the Statistics of Trade (Amendment) Act (Northern Ireland) 1971(c)) and of every other power enabling it in that behalf, hereby makes the following Order:

Citation and commencement

1. This Order may be cited as the Statistics of Trade (Amendment) Order (Northern Ireland) 1975 and shall come into operation on 1st January 1976.

Amendment of the Schedule

2. The Schedule to the Statistics of Trade Act (Northern Ireland) 1949 (which lists matters about which a person carrying on an undertaking may be required to furnish returns) shall be amended as follows:

- (a) In Part I at the end there shall be added the following entries:
 - "the persons employed and the value of work done in pursuance of any building or civil engineering contract which is being carried out by the undertaking (including the persons employed and the value of work done by any undertakings which have subcontracted with the undertaking in respect of that contract); the names and addresses of undertakings which have subcontracted with the undertaking in respect of any building or civil engineering contract;

the Value Added Tax registration number of the undertaking.":

- (b) in Part II-
 - (i) in the fifth entry after the word "value" there shall be inserted the words "and quantity"; and
 - (ii) at the end thereof there shall be added the following entry:
 - "the Value Added Tax registration number of the undertaking.";
- (c) in Part III—
 - (i) in the sixth entry after the word "acquisition" there shall be inserted the words "and disposal"; and
 - (ii) at the end thereof there shall be added the following entries: "the debts owed to the undertaking;

the transport charges;

the premises occupied by the undertaking;

the Value Added Tax registration number of the undertaking.".

EXPLANATORY NOTE

(This note is not part of the Order but is intended to indicate its general purport.)

This Order further amends the Schedule to the Statistics of Trade Act (Northern Ireland) 1949 and prescribes certain additional matters about which a person carrying on an undertaking in the fields of (i) production, (ii) wholesale distribution, (iii) retail distribution and other services, may be required to furnish returns.
