Rainbow Trout Waters Byelaws (Northern Ireland) 1975

Made 24th November 1975

Coming into operation 1st February 1976

The Fisheries Conservancy Board for Northern Ireland, in exercise of its powers under section 26 of the Fisheries Act (Northern Ireland) 1966(a) and of every other power enabling it in that behalf, with the approval of the Department(b) of Agriculture hereby makes the following Byelaws:

1. These Byelaws may be cited as the Rainbow Trout Waters Byelaws (Northern Ireland) 1975, and shall come into operation on 1st February 1976.

2. There shall be no close season for angling for rainbow trout in the following waters:

 Holybank Bleachworks Dam, Belfast

3. The Rainbow Trout Waters Byelaws (Northern Ireland) 1974(c) are hereby revoked.

EXPLANATORY NOTE

(This note is not part of the Byelaws but is intended to indicate their general purport.)

These Byelaws designate a number of waters as rainbow trout waters and provide that there shall be no close season for angling for rainbow trout in those waters.
