The Registrar of Friendly Societies for Northern Ireland, with the consent of the Department(a) of Commerce, in exercise of the powers conferred upon him by section 55(4) of the Friendly Societies Act (Northern Ireland) 1970(b) and of all other powers enabling him in that behalf, hereby makes the following Order:

Citation and commencement

1. This Order may be cited as the Friendly Societies (Limits of Benefits) Order (Northern Ireland) 1976 and shall come into operation on 1st June 1976.

Limits of benefits

2. The limits in paragraphs (c) and (d) of section 55(1) of the Friendly Societies Act (Northern Ireland) 1970, as increased by the Friendly Societies (Limits of Benefits) Order (Northern Ireland) 1970(c) and further increased by the Friendly Societies (Limits of Benefits) Order (Northern Ireland) 1973(d) (which govern the amount which members of registered friendly societies and branches may be entitled to receive under life or endowment business which is not tax exempt), shall be further increased as follows:

- (a) in paragraph (c) (relating to gross sums) the limit of £5,000 or, in the case of entitlement under mortgage protection policies, $\pounds 7,250$ shall be increased to $\pounds 10,000$ whether or not the entitlement or any part thereof is under any mortgage protection policy or policies;
- (b) in paragraph (d) (relating to annuities) the limit of $\pounds 500$ shall be increased to £1,000.

EXPLANATORY NOTE

(This note is not part of the Order but is intended to indicate its general purport.)

This Order raises the limits of the amounts which a member of a registered friendly society or branch may be entitled to receive from any one or more of such societies or branches under non-tax exempt business.

The increases are as follows (i) the limit of £5,000 under life or endowment business (or £7,250 under mortgage protection policies) is raised to £10,000 whether or not any part of the entitlement is under a mortgage protection policy or policies, and (ii) the limit of £500 by way of annuity is raised to £1,000.
