County Court (Mental Health Act) Rules (Northern Ireland) 1978

Made . . . . . 14th December 1978

Coming into operation . . . . . 1st March 1979

To be laid before Parliament

The Secretary of State, in pursuance of section 146 of the County Courts Act (Northern Ireland) 1959(a) and section 44 of the Mental Health Act (Northern Ireland) 1961(b) on the recommendation of the County Court Rules Committee and after consultation with the Lord Chief Justice, hereby makes the following rules:

Citation and commencement

1. These rules may be cited as the County Court (Mental Health Act) Rules (Northern Ireland) 1978 and shall come into operation on 1st March 1979.

Interpretation

2. In these rules—

“the Act” means the Mental Health Act (Northern Ireland) 1961;

“place of residence” means, in relation to a patient who is receiving treatment as an in-patient in a hospital, that hospital;

and a section referred to by number means the section so numbered in the Act.

Applications under Part II of the Act

3.—(1) An application under Part II of the Act shall be made to the court for the county court division in which the patient’s place of residence is situated or, in the case of an application made under section 42 for the discharge of an order made under section 41, to that court or the court which made the order.

(2) Notice of the application shall be given in Form 1, 2 or 3 in the Schedule, as the case may be, and shall be served on the clerk of the Crown and peace and the respondent not less than ten days before the day appointed for the sitting of the court at which the application is sought to be heard or within such period as the Judge may upon an ex parte application direct.

(3) Where an application is made under section 23(3) (to transfer guardianship of patient to a Health and Social Services Board or to some other person) the person having guardianship of the patient shall be the respondent.

(4) Where an application is made under section 41 (for order that functions of nearest relative of patient shall be exercisable by a Health and Social Services Board or some other person) the nearest relative shall be the respondent unless the application is made on the ground specified in section 41(3)(a).

(5) The court may order that any other person, not being the patient, shall be made a respondent.

(6) On the hearing of the application the court may accept as prima facie evidence of the facts stated therein any report made by a medical practitioner and any report made in the course of his official duties by—

(a) a probation officer; or

(b) a social worker as defined by the Act;

(c) an officer of a Health and Social Services Board;

but the respondent shall be told the substance of any part of the report bearing on his fitness or conduct which the Judge considers to be material to the manner in which the application should be dealt with.

(7) Unless the Judge otherwise orders, an application under Part II of the Act shall be heard and determined in chambers.

(8) For the purpose of determining the application the Judge may interview the patient either in the presence of or separately from the parties and either at the court or elsewhere or may direct the clerk of the Crown and peace or registrar to interview the patient and report to the Judge in writing.

## EXPLANATORY NOTE

*(This note is not part of the Rules but is intended to indicate their general purport)*

These rules govern the procedure to be adopted on applications to the county court under Part II of the Mental Health Act (Northern Ireland) 1961. The applications concerned are for an order transferring the guardianship of a patient to a Health and Social Services Board or other person approved for the purpose by that Board where it is alleged that the person having the guardianship has acted negligently or in a manner contrary to the interests of the patient or alternatively for an order directing that the functions under that Part of the Act of the nearest relative of the patient shall be exercisable by the applicant or some other person.
