Health and Safety at Work (1978 Order) (Commencement) Order (Northern Ireland) 1978

In exercise of the powers conferred upon me by Article 1(2) of the Health and Safety at Work (Northern Ireland) Order 1978(a), and of every other power enabling me in that behalf, I hereby make the following Order:

Citation and commencement

1. This Order may be cited as the Health and Safety at Work (1978 Order) (Commencement) Order (Northern Ireland) 1978 and shall come into operation on 18th January 1979.

Appointed days

- 2.—(1) The provisions of the Health and Safety at Work (Northern Ireland) Order 1978 specified in the first column of the Schedule to this Order shall come into operation on 1st February 1979.
- (2) The remaining provisions of that Order shall come into operation on 1st May 1979.
