Milk (Amendment No. 2) Regulations (Northern Ireland) 1980

Made 29th September 1980

Coming into operation 1st October 1980

The Department(a) of Agriculture, in exercise of the powers conferred on it by sections 1(3)(a)(i)(b), 1(3)(b)(ii)(c), 3(1)(d) and 9(1) of the Milk Act (Northern Ireland) 1950(e) and of every other power enabling it in that behalf, hereby makes the following regulations:

Citation and commencement

1. These regulations may be cited as the Milk (Amendment No. 2) Regulations (Northern Ireland) 1980 and shall come into operation on 1st October 1980.

Amendment to the Regulations of 1963

2. Paragraph (4)(b)(f) of Regulation 30 of the Milk Regulations (Northern Ireland) 1963(g) shall be revoked.

EXPLANATORY NOTE

(This note is not part of the Regulations, but is intended to indicate their general purport.)

These Regulations amend the Milk Regulations (Northern Ireland) 1963 (as amended) by revoking the requirement for bottle caps or cartons, cans or other containers approved by the Department any of which contain pasteurised milk to be marked with the day of the week on which the milk was pasteurised.

The provision made by Regulation 30(4)(b) which was introduced by Regulation 2(3) of the Milk (Amendment) Regulations (Northern Ireland) 1980 will not take effect as a result of Regulation 2 of these Regulations.
