The Department of the Environment, in exercise of the powers conferred by Articles 3, 5(1) and 13(2)(e) of the Building Regulations (Northern Ireland) Order 1979(a) and now vested in it(b), and of every other power enabling it in that behalf, after consultation with the Building Regulations Advisory Committee and such other bodies as appear to the Department to be representative of the interests concerned, hereby makes the following regulations:—

Citation and commencement

1. These regulations may be cited as the Building (Prescribed Fees) (Amendment) Regulations (Northern Ireland) 1983 and shall come into operation on 1st January 1984.

Interpretation

2. In these Regulations "the 1982 Regulations" means the Building (Prescribed Fees) Regulations (Northern Ireland) 1982(c).

Transitional provision

3. The 1982 Regulations shall apply in relation to work of which plans were first deposited after 31st December 1982 and before 1st January 1984 as if the amendments effected by regulation 4 had not been made.

Amendment of the 1982 Regulations

4.—(1) After regulation 6 of the 1982 Regulations there shall be inserted the following regulation—

"Exemption: work for the benefit of disabled persons

6A,—(1) A district council shall not charge a plan fee or an inspection fee where it is satisfied that the work in question—

- (a) is solely for the purpose of providing means of access for disabled persons to or within a building, or of providing facilities designed to secure their greater health, safety, welfare or convenience; and
- (b) is to be, or has been, carried out in relation to—
 - (i) a building to which members of the public are admitted (whether on payment or otherwise); or
 - (ii) a dwelling which is, or is to be, occupied by a disabled person.

(2) In this regulation "disabled person" means a person who is blind, deaf or dumb, or who is substantially and permanently handicapped by illness, injury or congenital deformity."

EXPLANATORY NOTE

(This note is not part of the Regulations.)

These regulations amend the Building (Prescribed Fees) Regulations (Northern Ireland) 1982. They increase by about 7% the plan fees and inspection fees payable to district councils. They also exempt from fees work done to dwellings and public buildings solely for the benefit of the disabled.
