**ROAD TRAFFIC AND VEHICLES**  
**Off-Street Parking (Amendment) Bye-Laws**  
**(Northern Ireland) 1983**

*Made* . . . . . 28th March 1983

*Coming into operation* . . . . . 2nd May 1983

The Department of the Environment in exercise of the powers conferred on it by Article 105(1) of the Road Traffic (Northern Ireland) Order 1981(a) and of all other powers enabling it in that behalf hereby makes the following Bye-Laws:—

*Citation and commencement*

1. These Bye-Laws may be cited as the Off-Street Parking (Amendment) Bye-Laws (Northern Ireland) 1983 and shall come into operation on 2nd May 1983.

*Bye-Laws amended*

2. The Off-Street Parking Bye-Laws (Northern Ireland) 1976(b) shall be amended by:—

- (a) the addition to Schedule 1 Part 1 of the car parks in Schedule 1.
- (b) by the substitution for items 127 and 132 in Schedule 1 Part 1 of the provisions in Schedule 2.
