# Industrial and Provident Societies (Fees) (Amendment) Regulations (Northern Ireland) 1984

The Department of Economic Development, in exercise of the powers conferred by section 97(1) of the Industrial and Provident Societies Act (Northern Ireland) 1969(a) and now vested in it(b) and of every other power enabling it in that behalf, hereby makes the following regulations:

### Citation and commencement

1. These regulations may be cited as the Industrial and Provident Societies (Fees) (Amendment) Regulations (Northern Ireland) 1984 and shall come into operation on 9th July 1984.

#### Revocation

2. The Industrial and Provident Societies (Fees) (Amendment) Regulations (Northern Ireland) 1983(c) are hereby revoked.

# Amendment of fees

3. For Schedule 2(d) to the Industrial and Provident Societies Regulations (Northern Ireland) 1969(e) there shall be substituted the following Schedule:

For a document certified as a true copy of a document on a file kept as aforesaid, where the copy so certified is not made by the Registrar, £2 for the examination of such copy, and, if the copy exceeds 216 words, for every additional folio of 72 words or part thereof, 45p (in addition to the fee for the signature of the Registrar): provided that the fee to be charged for the examination and authentication of copies of rules or amendments of rules required for the purposes of recording shall not be greater than the fee paid for acknowledgment of registration of the society or of the amendment of rules as the case may be.	
For the acknowledgment of registration of a society the rules of which are in the form of model rules, where the application for the registration is made through and endorsed by the association or body which has sponsored the rules

### **EXPLANATORY NOTE**

(This note is not part of the regulations.)

These regulations increase by approximately 15% the fees to be paid for matters transacted or arising under the Industrial and Provident Societies Act (Northern Ireland) 1969 in relation to industrial and provident societies other than credit unions. The regulations supersede the Industrial and Provident Societies (Fees) (Amendment) Regulations (Northern Ireland) 1983.
