**The Social Security (1985 Order) (Commencement No. 2) Order
(Northern Ireland) 1985**

Made 13th September 1985

The Department of Health and Social Services, in exercise of the powers conferred on it by Article 1(3) of the Social Security (Northern Ireland) Order 1985(a), paragraph 2(1) of Schedule 1 to the Northern Ireland Act 1974(b) and of all other powers enabling it in that behalf, hereby makes the following order:

1. This order may be cited as the Social Security (1985 Order) (Commencement No. 2) Order (Northern Ireland) 1985.

EXPLANATORY NOTE

(This note is not part of the Order.)

This order brings into operation, on various dates in 1985 and 1986, all those provisions of the Social Security (Northern Ireland) Order 1985 which are not brought into operation either by Article 1 of that Order or by the Social Security (1985 Order) (Commencement No. 1) Order (Northern Ireland) 1985 (S.R. 1985 No. 218 (C. 6)), except the provisions relating to the registration of occupational pension schemes.
