**The Fire Services (Office and Shop Premises) (Repeals) Order
(Northern Ireland) 1986***Made* 5th December 1986*Coming into operation* 1st February 1987

The Department of the Environment and the Department of Economic Development in exercise of the powers conferred by Article 47(2) of the Fire Services (Northern Ireland) Order 1984(a) and of every other power enabling them in that behalf jointly make the following Order:

Citation and commencement

1. This Order may be cited as the Fire Services (Office and Shop Premises) (Repeals) Order (Northern Ireland) 1986 and shall come into operation on 1st February 1987.

Repeals

2. In the Office and Shop Premises Act (Northern Ireland) 1966(b) the provisions mentioned in column 1 of the Schedule to this order are repealed to the extent specified in column 2.

Revocations — instruments under the Office and Shop Premises Act (Northern Ireland) 1966

3.—(1) The following instruments, that is to say:—

- (a) the Office and Shop Premises (Modification of Fire Certification) Regulations (Northern Ireland) 1967(c), and
- (b) the Office and Shop Premises (Annual Reports) Order (Northern Ireland) 1967(d)

are revoked.

(2) In the Office and Shop Premises (Forms) Order (Northern Ireland) 1967(e) Article 2 and Schedule 1 are revoked.

EXPLANATORY NOTE

(This note is not part of the Order.)

This Order repeals provisions of the Office and Shop Premises Act (Northern Ireland) 1966 and revokes instruments made thereunder relating to fire precautions.

It is made in consequence of the coming into operation on 1st February 1987 of:—

- (i) The Fire Services (Factory, Office and Shop Premises) Order (Northern Ireland) 1986 (S.R. 1986 No.355), and
- (ii) The Fire Services (Non-Certificated Factory, Office and Shop Premises) Regulations (Northern Ireland) 1986 (S.R. 1986 No. 352)

which together supersede the provisions repealed by this order.
