The Animals (Scientific Procedures) (1986 Act) (Commencement No. 1) Order (Northern Ireland) 1986

The Department of Health and Social Services for Northern Ireland, in exercise of the powers conferred on it by section 30(3) of the Animals (Scientific Procedures) Act 1986(a) as adapted by section 29 of that Act and of all other powers enabling it in that behalf, hereby makes the following order:

Citation and interpretation

1.—(1) This order may be cited as the Animals (Scientific Procedures) (1986 Act) (Commencement No. 1) Order (Northern Ireland) 1986.

(2) In this order "the Act" means the Animals (Scientific Procedures) Act 1986.

Day appointed for the coming into operation of certain provisions of the Act

2. The day appointed for the coming into operation of each provision of the Act, which is specified in column (1) of the Schedule to this order, shall be 1st January 1987.

EXPLANATORY NOTE

(This note is not part of the Order.)

This order brings into operation on 1st January 1987 the majority of provisions of the Animals (Scientific Procedures) Act 1986 which makes new provision for the protection of animals used for experimental or other scientific purposes. Those provisions of the Act not being brought into effect on 1st January 1987 are sections 7 and 10(3) and Schedule 2 which relate to designated breeding and supplying establishments.
