**MAGISTRATES' COURTS****Magistrates' Courts (Costs in Affiliation and Separation and Maintenance Proceedings) (Amendment) Rules (Northern Ireland) 1986***Made* . . . . . 26th March 1986*Coming into operation* . . . . . 1st May 1986

The Lord Chancellor, in exercise of the powers conferred on him by Article 13 of the Magistrates' Courts (Northern Ireland) Order 1981(a) on the advice of the Magistrates' Courts Rules Committee and after consultation with the Lord Chief Justice, hereby makes the following rules:

*Citation and commencement*

1. These rules may be cited as the Magistrates' Courts (Costs in Affiliation and Separation and Maintenance Proceedings) (Amendment) Rules (Northern Ireland) 1986 and shall come into operation on 1st May 1986.

*Interpretation*

2. In these rules—

“the Principal Rules” means the Magistrates' Courts (Costs in Affiliation and Separation and Maintenance Proceedings) Rules (Northern Ireland) 1966(b).

*Amendment to the Principal Rules*

3. In rule 1(1) of the Principal Rules after sub-paragraph (f) there shall be added the following sub-paragraph:

“(g) the Domestic Proceedings (Northern Ireland) Order 1980;”(c).

4. In the Schedule to the Principal Rules in paragraphs (a) and (b) for the sum of £60 there shall be substituted the sum of £130.

**Medicines (Products Other Than Veterinary Drugs)  
(Prescription Only) Amendment Order 1986**

This Order has been made by the Secretary of State concerned with health in England, the Secretaries of State respectively concerned with health and with agriculture in Scotland and in Wales, the Minister of Agriculture, Fisheries and Food, the Department of Health and Social Services for Northern Ireland, and the Department of Agriculture for Northern Ireland, acting jointly, in exercise of the powers conferred by sections 58(1)(4) and 129(4) of the Medicines Act 1968.

In pursuance of paragraph 11 of Schedule 4 to that Act this Order has been registered as a Northern Ireland statutory rule under the Statutory Rules (Northern Ireland) Order 1979. It is printed in full in the volume of United Kingdom Statutory Instruments for 1986 and has been numbered 586 in that series.
