Fisheries (Amendment No. 2) Byelaws (Northern Ireland) 1992

Made 19th August 1992 Coming into operation . 30th September 1992

The Fisheries Conservancy Board for Northern Ireland, in exercise of the powers conferred on it by sections 26(1), 72(1), and 95 of the Fisheries Act (Northern Ireland) 1966(a) and of every other power enabling it in that behalf, with the approval of the Department of Agriculture hereby makes the following byelaws:

Citation and commencement

1. These Byelaws may be cited as the Fisheries (Amendment No. 2) Byelaws (Northern Ireland) 1992 and shall come into operation on 30th September 1992.

Amendment of the Fisheries Consolidated and Amendment Byelaws (Northern Ireland) 1989

- 2. The Fisheries Consolidated and Amendment Byelaws (Northern Ireland) 1989(b) shall be amended as provided in byelaws 3 to 5.
 - 3. In Part XVI—
 - (a) in byelaw 73 for the words ", the River Erne and in the River Bush and all rivers entering therein" there shall be substituted "and the River Erne"; and
 - (b) after byelaw 73 there shall be inserted—

"73A. In the River Bush and all rivers entering therein, the close season for angling for salmon, trout, and rainbow trout shall be from 21st October in each year to the last day of February in the next following year (both dates inclusive).".

List of waters on which a coarse fishing rod licence is valid

- 4. In Schedule 2—
- (a) under Co. Antrim and Co. Londonderry for the words "the railway" in each case there shall be substituted the word "railway"; and

- (b) under Co. Armagh after "Clay," there shall be inserted "Craigavon City Park Lakes North Lake,"
- (c) under Co. Tyrone there shall be deleted ", White".

List of waters where there is no close season for rainbow trout

- 5. In Schedule 4—
- (a) after the reference to "Derryleckagh Lake, Co. Down" there shall be inserted references to "Finnebrogue Fisheries, Co. Down" and "Hillsborough Lake, Co. Down" and after Magheralagan Lake, Co. Down, there shall be inserted "Marybrook Fisheries, Co. Down";
- (b) after the reference to "Dungannon Park Lake, Co. Tyrone" there shall be inserted a reference to "White Lough, Co. Tyrone"; and
- (c) for the word "Gauher's" there shall be substituted "Gauger's".

Fisheries EXPLANATORY NOTE

(This note is not part of the Byelaws.)

These Byelaws further amend the Fisheries Consolidated and Amendment Byelaws (Northern Ireland) 1989 (the 1989 Byelaws).

The principal changes are as follows:—

- 1. Byelaw 3 alters the close season for the River Bush so that angling is permitted from 1st March to 20th October in any year instead of from 1st March to 30th September.
- 2. Byelaw 4(b) and (c) removes White Lough, Co. Tyrone, from the list of waters in Schedule 2 to the 1989 Byelaws on which a coarse fishing rod licence is valid, and adds Craigavon City Park Lakes North Lake to the list.
- 3. Byelaw 5(a) and (b) adds to the list of waters in Schedule 4 to the 1989 Byelaws in which there is no close season for angling for rainbow trout Finnebrogue Fisheries, Co. Down; Hillsborough Lake, Co. Down; Marybrook Fisheries, Co. Down, and White Lough, Co. Tyrone.

Byelaws 4(a) and 5(c) correct minor errors in the 1989 Byelaws.
