The Department of Agriculture, in exercise of the powers conferred on it by sections $2(\mathbf{a})$, $3(1)(\mathbf{b})$, $3A(\mathbf{c})$, $3B(1)(\mathbf{d})$ and $4(1)(\mathbf{e})$ of the Plant Health Act (Northern Ireland) 1967(f) and of all powers enabling it in that behalf, hereby makes the following Order:

Citation and commencement

1. This Order may be cited as the Plant Health (Amendment) Order (Northern Ireland) 1995 and shall come into operation on 14th June 1995.

Amendment of the Plant Health Order (Northern Ireland) 1993

2. The Plant Health Order (Northern Ireland) 1993(g) shall be amended in accordance with Articles 3 to 18.

3. In Article 3(1) (Interpretation)—

- (a) after the definition of "inspector" there shall be inserted the following definition-
 - " "Ireland" and "United Kingdom" shall have the same respective meanings as in Directive 77/93/EEC;";
- (b) after the definition of "responsible person" there shall be inserted the following definition-
 - " "the ring rot Directive" means Council Directive 93/85/EEC of 4th October 1993 on the control of potato ring rot(h);".

4. In Article 4(1) (Prohibition on landing from a third country of pests, plants etc) for the words "A person shall not land" there shall be substituted the words "There shall not be landed".

5. In Article 4(2)(d)(ii)(E) after the words "other plants" there shall be inserted "not being potatoes".

6. In Article 6 (Prohibition on introduction into protected zones of pests, plants etc)---

- (a) in paragraph (1) for the words "A person shall not introduce" there shall be substituted "There shall not be introduced"; and
- (b) in paragraph (2) for the words "a person shall not introduce" there shall be substituted "there shall not be introduced".

7. In Article 19(1) (Restriction on the planting of potatoes) the word "Austria," shall be deleted.

8. After Article 22(3) (Actions which may be required by an inspector) there shall be inserted a new paragraph 22(3A)—

"22(3A) An inspector may, by notice in writing served on the consignee of any plants, plant products or other objects which have been or are to be landed, specify premises and require the removal of those objects to those premises in such manner as may be specified in the notice.".

9. For Articles 38 to 42 (Potato ring rot) there shall be substituted— *"Special measures for the control of potato ring rot"*

38. It shall be the duty of the Department to give effect to the requirements of paragraphs (1) and (2) of article 2, paragraph (1) of article 4 and articles 5 and 6 of the ring rot Directive.

39. A person who suspects the occurrence or actual presence of potatoring rot in growing potatoes or harvested, stored or marketed tubers shall immediately notify the Department or an inspector who shall determine whether or not any further investigation is necessary.

40. Subject to Article 41(2), a person shall not—

- (a) hold or handle any plant or tuber affected with potato ring rot or any other object or material affected with it otherwise than in compliance with the provisions of Articles 39 to 42;
- (b) plant any tuber or plant designated to be contaminated with potato ring rot under article 5(1)(a) of the ring rot Directive and a notice under paragraph (1)(c) or (2)(i) of Article 22 may require any such tuber or plant to be disposed of otherwise than by destruction only by means of measures described in point 1 of Annex IV to the ring rot Directive and only if there is no identifiable risk of potato ring rot spreading;
- (c) plant any plant or tuber determined as probably contaminated with potato ring rot under article 5(1)(b) of the ring rot Directive and a notice under paragraph (1)(c) or (2)(i) of Article 22 may require any such tuber or plant to be put to an appropriate use or disposed

of only in accordance with point 2 of Annex IV to the ring rot Directive and only if there is no identifiable risk of potato ring rot spreading.

41.—(1) Subject to paragraph (2), a notice under paragraph (1)(c) or (2)(i) of Article 22 may require any machinery, vehicle, vessel, store or units thereof and any other objects including packaging material designated as contaminated under article 5(1)(a) of the ring rot Directive or determined as probably contaminated under paragraph (1)(b) of that article to be—

- (a) disposed of otherwise than by destruction; or
- (b) cleansed and disinfected using appropriate methods as specified in point 3 of Annex IV to the ring rot Directive, whereupon they shall not be treated as contaminated.

(2) The Department or an inspector may by notice in writing given to the person having possession of any plants or tubers exempt those plants or tubers from the requirements of article 6 of the ring rot Directive (as applied by Article 38) and of Article 40 and paragraphs (1) and (3) for experimental or scientific purposes or for work on varietal selection if it or he as the case may be is satisfied that any such exemption would not prejudice the control of potato ring rot or create a risk of its spread.

(3) Subject to paragraph (2) and without prejudice to the provisions of Article 40(b) and (c) and paragraph (1), a notice under Article 22 may require a series of measures as specified in point 4 of Annex IV to the ring rot Directive to be implemented.

42.—(1) A person shall not plant seed potatoes unless they—

- (a) meet the requirements of Directive 77/93/EEC on the protective measures against the introduction into the Community of organisms harmful to plants or plant products and against their spread within the Community(a); and
- (b) derive in a direct line from material obtained under an officially approved programme which has been found free from potato ring rot in official or officially supervised testing pursuant to article 8(1) of the ring rot Directive using the method set out in Annex I to that Directive.
- (2) The testing referred to in paragraph (1)(b) shall be carried out—
- (a) in a case where contamination affects seed potato production, on the plants in the initial clonal selection; and
- (b) in any other case, either on the plants of the initial clonal selection or on representative samples of the basic seed potatoes or earlier propagations.".

- (ii) in column (3) opposite Item 16 in column 1 for the words "Seeds and bulbs of: Allium cepa L., Allium porrum L. and Allium schoenoprasum L." there shall be substituted "Seeds and bulbs of: Allium ascalonicum L., Allium cepa L. and Allium schoenoprasum L. intended for planting and plants of Allium porrum L. intended for planting.";
- (iii) in column (3) opposite Items 32 and 34 the words "fruit and" shall be deleted in both places where they occur;
- (b) in Part A, Section B, Item 9 shall be deleted;
- (c) in Part A, Section C, in column (3) for the words opposite Item 13 there shall be substituted-

"Plants of *Fortunella* Swingle, *Poncirus* Raf., and their hybrids, other than fruit and seeds and plants of *Citrus* L. and their hybrids, other than seeds and fruit, except fruit of *Citrus reticulata* Blanco and of *Citrus sinensis* (L.) Osbeck, originating in South America.";

- (d) in Part B, Section A

- (a) originate from a field known to be free from *Globodera* rostochiensis (Wollenweber) Behrens and *Globodera* pallida (Stone) Behrens; and
- (b) originate in areas in which *Pseudomonas solanacearum* (Smith) Smith is known not to occur, or where the tubers originate in areas where *Pseudomonas solanacearum* (Smith) Smith is known to occur, that the tubers originate from a place of production found free from *Pseudomonas solanacearum* (Smith) Smith, or considered to be free

EXPLANATORY NOTE

(This note is not part of the Order.)

This Order which amends the Plant Health Order (Northern Ireland) 1993 implements as respects Northern Ireland—

- (a) Commission Directive 93/106/EC (O.J. No. L.298, 3.12.93, p. 34) which makes changes in Commission Directive 92/76/EEC (O.J. No. L.305, 21.10.92, p. 12);
- (b) Commission Directive 93/110/EC (O.J. No. L.303, 10.12.93, p. 19) which makes changes in Council Directive 77/93/EEC (O.J. No. L.26, 31.1.77, p. 20) relating to certain protected zones; and
- (c) Commission Directive 95/4/EC (O.J. No. L.44, 28.2.95, p. 56) which makes changes in Council Directive 77/93/EEC relating to the disease *Pseudomonas solanacearum* and the pest *Thrips palmi*.

The Order makes the following principal changes-

- 1. An inspector may require the consignee of a plant, plant product or other object to remove it to premises specified in a notice (Article 8).
- 2. Citrus tristeza virus is added to the list of pests which may not be introduced into certain protected zones and whose spread within those zones is prohibited if they are present on certain plants and plant products (Article 11(f)).
- 3. Amendments are made to the conditions to be met before certain plants, plant products and other objects may be landed or moved within the European Community or introduced or moved within certain protected zones.

The Order makes provisions consequential upon the Accession of Austria, Finland and Sweden to the plant health single market on 1st January 1995.

The Order also revokes the Plant Health (Amendment) (Potatoes) Order (Northern Ireland) 1994.
