ROAD TRAFFIC AND VEHICLES

Roads (Speed Limit) (No. 4) Order (Northern Ireland) 1995

Made . . . . . 28th December 1995

Coming into operation . . . . . 8th February 1996

The Department of the Environment, in exercise of the powers conferred on it by Article 50(4)(c) of the Road Traffic (Northern Ireland) Order 1981(a) and of every other power enabling it in that behalf, hereby makes the following Order:

*Citation and commencement*

1. This Order may be cited as the Roads (Speed Limit) (No. 4) Order (Northern Ireland) 1995 and shall come into operation on 8th February 1996.

*Speed restrictions on certain roads*

2. The Department hereby directs that each of the roads and lengths of road specified in the Schedule shall be a restricted road for the purposes of Article 50 of the Road Traffic (Northern Ireland) Order 1981.

*Revocation*

3. Item 43 of the Second Schedule to the Roads (Speed Limit) (No. 4) Order (Northern Ireland) 1963(b) is hereby revoked.

*Restricted Roads*

1. Ardnabannon Road, Route A25, Annsborough, Castlewellan, from its junction with Ballylough Road, Route B175, to a point approximately 225 metres north-east of that junction.
2. Craigs Road, Ballynahinch.
3. Glenlough, Ballynahinch.
4. Glenlough Park, Ballynahinch.
5. Hilltop, Ballynahinch.
6. Knowes Crescent, Ballynahinch.
7. Tudor Oaks, Ballynahinch.
8. The new link road, Belfast, from its junction with Saintfield Road, to its junction with the new roundabout at Purdysburn Road.
9. Killaughey Road, Route C253, Donaghadee, from its junction with Millisle Road, to a point approximately 880 metres south-west of its junction with Northfield Road.
10. Newry Road, Route B8, Hilltown, from its junction with Main Street, to a point approximately 25 metres west of its junction with Yellow Road.
11. Bangor Road, Route A21, Newtownards, from a point approximately 35 metres north of its junction with Rosevale Avenue, to a point approximately 690 metres north of its junction with North Road.
12. Old Belfast Road, Unclassified No. 9001, Newtownards, from its junction with Scrabo Road, to a point approximately 615 metres west of that junction.
13. Old Shore Road, Unclassified No. 126, Newtownards, from its junction with Upper Greenwell Street, to a point approximately 80 metres north of its junction with Portaferry Road.
14. Scrabo Road, Unclassified No. 243, Newtownards, from its junction with Old Belfast Road, to a point approximately 357 metres south of that junction.

**EXPLANATORY NOTE**

*(This note is not part of the Order.)*

This Order makes the roads and lengths of road in the Schedule restricted roads, thereby imposing a 30 miles per hour speed limit on those roads.

The length of road to which the item revoked under Article 3 relates is now comprised in a greater length of road described in item No. 11 of the Schedule.
