**ROAD TRAFFIC AND VEHICLES**

**The Parking Places on Roads (Strabane) (Amendment) Order  
(Northern Ireland) 2010**

*Made* - - - - -

*16th August 2010*

*Coming into operation* -

*7th September 2010*

The Department for Regional Development(a) makes the following Order in exercise of the powers conferred by Articles 10(4) and 13(1) of the Road Traffic Regulation (Northern Ireland) Order 1997(b) and now vested in it(c).

It appears to the Department to be necessary to provide suitable parking places for vehicles on the parts of the road specified in Article 2.

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 4 to the Road Traffic Regulation (Northern Ireland) Order 1997.

The Department has published a Notice in compliance with paragraphs 1 and 3 of that Schedule.

The Department, in compliance with paragraph 3(4) of that Schedule, has taken such other steps as appear to the Department reasonably practicable for the purpose of bringing specifically to the knowledge of the occupiers of land adjacent to the parking places the particulars specified in paragraph 3(2) of that Schedule.

No written objection or other representation has been received.

**Citation and commencement**

**1.** This Order may be cited as The Parking Places on Roads (Strabane) (Amendment) Order (Northern Ireland) 2010 and shall come into operation on 7th September 2010.

**Amendment**

**2.** The Parking Places on Roads (Strabane) Order (Northern Ireland) 2008(d) shall be amended by the addition to the Schedule of the following items—

“5. Railway Street, Strabane (south-west side) – from a point 26 metres south-east of its junction

(b) S.I. 1997/276 (N.I. 2)

(c) S.R. 1999 No. 481 Article 6(d) and Schedule 4 Part IV

(d) S.R. 2008 No. 335 as amended by S.R. 2008 No. 398

- with John Wesley Street for a distance of 12 metres.
6. Railway Street, Strabane (south-west side) – from a point 64 metres south-east of its junction with John Wesley Street for a distance of 11 metres.”

## **EXPLANATORY NOTE**

*(This note is not part of the Order)*

This Order amends The Parking Places on Roads (Strabane) Order (Northern Ireland) 2008 (“the Order”) by the addition to the Schedule of the items specified in Article 2.

A penalty charge (£60) is payable with respect to a vehicle involved in a contravention of the Order in accordance with the Traffic Management (Northern Ireland) Order 2005 and The Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.
