The Department of Agriculture and Rural Development⁽¹⁾, makes the following Order in exercise of the powers conferred on it by section 59 of the Welfare of Animals Act (Northern Ireland) 2011⁽²⁾.

Citation and interpretation

1.—(1) This Order may be cited as the Welfare of Animals (2011 Act) (Commencement and Transitional Provisions No.1) Order (Northern Ireland) 2011.

(2) In this Order “the Act” means the Welfare of Animals Act (Northern Ireland) 2011.
