# The Pensions (2012 Act) (Commencement No. 3) Order (Northern Ireland) 2013

Made - - - 26th March 2013

The Department for Social Development makes the following Order in exercise of the powers conferred by section 34(3) of the Pensions Act (Northern Ireland) 2012(1).

#### Citation and interpretation

- **1.**—(1) This Order may be cited as the Pensions (2012 Act) (Commencement No. 3) Order (Northern Ireland) 2013.
- (2) In this Order any reference to a numbered section or Schedule is to the section of, or Schedule to, the Pensions Act (Northern Ireland) 2012 bearing that number.

#### Appointed day

- 2. The day appointed for the coming into operation of—
  - (a) section 22 (Pension Protection Fund) in so far as it is not already in operation, and
  - (b) in Schedule 4 (Pension Protection Fund)—
    - (i) paragraph 1 in so far as it is not already in operation;
    - (ii) paragraphs 21 to 28 (postponement of compensation), and
    - (iii) paragraphs 29 to 36 (pension compensation sharing: postponement of compensation),

is 27th March 2013.
