**The Transport (2011 Act) (Commencement No.2) Order  
(Northern Ireland) 2015**

The Department for Regional Development makes the following Order in exercise of the powers conferred by section 48 of the Transport Act (Northern Ireland) 2011(a).

**Citation and interpretation**

1.—(1) This Order may be cited as the Transport (2011 Act) (Commencement No.2) Order (Northern Ireland) 2015.

(2) In this Order—

“the Act” means the Transport Act (Northern Ireland) 2011.

**Appointed day**

2. The appointed day for the coming into operation of the provisions of the Act specified in the Schedule for the purposes only of making regulations is 23rd June 2015.
