## RADIOACTIVE SUBSTANCES

## The Carriage of Dangerous Goods (Amendment) Regulations (Northern Ireland) 2019

Made 21st May 2019 Coming into operation 18th June 2019

The Department for the Economy(1), being the Department concerned(2), makes the following Regulations in exercise of the powers conferred by section 2(2) of, and paragraph 1A of Schedule 2 to, the European Communities Act 1972(3) ("the 1972 Act"), Articles 17(1), (2) and (4) of, and paragraphs 1(1), (2) and (4), 2, 8, 12 and 13 of Schedule 3 to the Health and Safety at Work (Northern Ireland) Order 1978 ("the 1978 Order")(4).

The Department was designated(5) for the purposes of section 2(2) of the 1972 Act in relation to safety measures in regard to radioactive substances and the emission of ionising radiation(6), measures relating to basic safety standards for health protection of the general public and workers against the dangers of ionising radiation, measures relating to informing the public about health protection measures to be taken in the event of a radiological emergency(7) and the environment(8).

These Regulations make provision for a purpose mentioned in section 2(2) of the 1972 Act and it appears to the Department that it is expedient for references to Council Directive 2013/59/ Euratom laying down basic safety standards for protection against the dangers arising from exposure to ionising radiation, and repealing Directives 89/618/Euratom, 90/641/Euratom, 96/29/Euratom, 97/43/Euratom and 2003/122/Euratom(9) to be construed as references to that Directive as amended from time to time.

The Regulations give effect without modifications to proposals submitted to it by the Health and Safety Executive for Northern Ireland under Article 13(1A)(10) of the 1978 Order after the Executive had carried out consultations in accordance with Article 46(3)(11).
